Cigarette tax; limiting certain amounts apportioned after specified date; providing for deposit of funds in excess of limit. Effective date. Emergency.

Income tax; allowing donation from refund to Oklahoma Department of Veterans Affairs Indigent Veteran Burial Program. Effective date.

Excise tax; requiring electronic remittance of certain tax; deleting certain additional payments of tax. Effective date. Emergency

Ad valorem taxes; modifying and adding definitions; conforming language to constitutional provision. Effective date
10. **SB 1277 By Sharp of the Senate and Banz of the House**
Motor vehicles; creating Sooner State ABATE special license plate; creating revolving fund. Effective date.
11. **SB 1282 By Jolley of the Senate and Echols of the House**
Sales tax; requiring Tax Commission to enhance certain efforts; exempting for certain materials used in manufacturing. Effective date.

Income tax; modifying reporting required by employers relating to withholding. Effective date.
