HB 1081 – By Sanders of the House and Marlatt of the Senate.

An Act relating to Public Competitive Bidding Act of 1974; amending 61 O.S. 2011, Section 121, as amended by Section 315, Chapter 304, O.S.L. 2012 (61 O.S. Supp. 2012, Section 121), which relates to change orders to public construction contracts; modifying approval requirements for certain change orders; and providing an effective date.

HB 1084 – By Grau of the House and Holt of the Senate.

An Act relating to private process servers; amending 12 O.S. 2011, Section 158.1, as amended by Section 1, Chapter 101, O.S.L. 2012 (12 O.S. Supp. 2012, Section 158.1), which relates to licensing private process servers; directing applicant to give notice of license hearing in certain publication; requiring applicant to pay publication fee; directing applicant to file proof of publication prior to hearing; mandating court clerk to mail or deliver notice to the district attorney prior to hearing; and declaring an emergency.

HB 1086 – By Grau of the House and Anderson of the Senate.

An Act relating to civil procedure; amending 12 O.S. 2011, Section 2502, which relates to attorney-client privilege; modifying term; and providing an effective date.

HB 1089 – By Grau of the House and Treat of the Senate.

An Act relating to counties and county officers; repealing 19 O.S. 2011, Section 322, which relates to county commissioner eligibility requirements; and providing an effective date.

HB 1639 – By Jordan of the House and Johnson (Rob) of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2011, Section 2001, which relates to the Oklahoma Health Spa Act; modifying definition; adding exception for certain facility; and providing an effective date.
