

LEGISLATION BY THE NUMBERS


Since May 2020:

- 34 states and Washington D.C. have introduced or filed legislation.
- 594 bills introduced or prefiled.
- 50 enacted bills/adopted resolutions.
- 14 bills awaiting executive action or in concurrence process.
- 357 measures currently pending.




- 20 states and Washington D.C. have enacted legislation. Topics include:




USE OF FORCE RESTRICTIONS & STANDARDS




Use of Force Restrictions & Standards Enactments






ALTERNATIVE RESPONSES & OFFICER WELLNESS

- CT HB 6004 Requires each municipal department to evaluate the benefits of using social workers during emergency response situations and report back to POST.
- MN HF 1 Authorizes and regulates the use of peer counseling for officers and critical incident stress management teams. Specifies that officers should exercise special care when interacting with individuals with known physical, mental, developmental or intellectual disabilities. Creates new training requirements on crisis intervention and interactions with individuals with autism.



EXECUTIVE ORDERS

- 10 states have signed executive orders.
- Orders in AR, NH and NY create new task forces.
- The CT order is substantive and addresses use of force, community engagement, demilitarization and body cameras.
- The PA order creates a citizens' commission.
- The MI order expands the membership of the Commission on Law Enforcement Standards.
- AZ & MN are emergency orders addressing immediate situation.
- The WI order called the legislature into special session.
- The VT order implements an initiative covering community participation, hiring practices, data, bodyworn cameras, use of force policy, training, and investigations.
