## First Regular Session of the Fifty-eighth Legislature of the State of Oklahoma

**Fourth Legislative Day, Wednesday, February 3, 2021**

The Senate was called to order by Senator Daniels.

### SENATE RULES SUSPENDED

President Pro Tempore Treat asked unanimous consent, which was granted, that pursuant to Senate Rule 1-5, the Senate suspend paragraph 6 of subsection A of Senate Rule 8-22 to allow for immediate consideration of **SB 1031**, and, subsection A of Senate Rule 8-23 to allow for immediate consideration of the Floor Substitute to **SB 1031**.

**GENERAL ORDER**

**SB 1031** by Treat of the Senate and Echols of the House was called up for consideration.

Senator Treat moved to amend **SB 1031**, by substituting the attached floor substitute for the title, enacting clause and entire body of the measure, which amendment was declared adopted. (Copies were provided for all Senators.)
