Senator Murdock moved to amend **SB 270**, Page 10, Line 19 ½, by adding a new Section 4 to read as follows:

“SECTION 4. AMENDATORY 59 O.S. 2011, Section 698.3, is amended to read as follows:

Section 698.3. A. The State Board of Veterinary Medical Examiners is hereby re-created, to continue until July 1, 2023 2025, in accordance with the provisions of the Oklahoma Sunset Law, to regulate and enforce the practice of veterinary medicine in this state in accordance with the Oklahoma Veterinary Practice Act.

B. 1. The duty of determining a person's initial and continuing qualification and fitness for the practice of veterinary medicine, of proceeding against the unlawful and unlicensed practice of veterinary medicine and of enforcing the Oklahoma Veterinary Practice Act is hereby delegated to the Board. That duty shall be discharged in accordance with the Oklahoma Veterinary Practice Act and other applicable statutes.

2. a. It is necessary that the powers conferred on the Board by the Oklahoma Veterinary Practice Act be construed to protect the health, safety and welfare of the people of this state.

b. No member of the Board, acting in that capacity or as a member of any Board committee, shall participate in the making of any decision or the taking of any action affecting such member's own personal, professional or pecuniary interest, or that of a person related to the member within the third degree by consanguinity, marriage or adoption or of a business or professional associate.

c. With advice of legal counsel, the Board shall adopt and annually review a conflict of interest policy to enforce the provisions of the Oklahoma Veterinary Practice Act.

C. The practice of veterinary medicine is a privilege granted by the people of this state acting through their elected representatives. It is not a natural right of individuals. In the interest of the public, and to protect the public, it is necessary to provide laws and rules to govern the granting and subsequent use of the privilege to practice veterinary medicine. The primary responsibility and obligation of the Board is to protect the public from the unprofessional, improper, incompetent and unlawful practice of veterinary medicine.

D. The liability of any member or employee of the Board acting within the scope of Board duties or employment shall be governed by The Governmental Tort Claims Act.”, which amendment was declared adopted.

Advising passage of and transmitting for consideration Engrossed **HB 2677**.

**HB 2677** – By Marti, Caldwell (Trey), Fugate, West (Tammy), Dollens, Davis and Sneed of the House and McCortney of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2011, Section 356.2, which relates to the Pharmacy Audit Integrity Act; modifying and expanding duties; prohibiting certain audits; providing for discrepancies; requiring acceptance of certain evidence; requiring provision of certain documents within specified time; providing audit requirements; modifying number of prescriptions to be audited; requiring invoices; modifying audit report time periods; eliminating certain withholdings; amending 59 O.S. 2011, Section 356.3, which relates to appeals process; clarifying when certain findings are to be referred to the district attorney; clarifying scope of application; amending Section 3, Chapter 263, O.S.L. 2014 (59 O.S. Supp. 2020, Section 359), which relates to information to be provided by pharmacy benefits manager; removing exceptions; amending Section 4, Chapter 263, O.S.L. 2014, as amended by Section 8, Chapter 285, O.S.L. 2016 (59 O.S.
