HB 2750 – By Baker, Hasenbeck, Vancuren, Talley, Conley and Caldwell (Chad) of the House and Pugh of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 3207.1, which relates to transfer of credits; declaring legislative intent; requiring credit policy be posted on the campus website; requiring biennial reviews of Advanced Placement credit policies; requiring reports of noncompliance; providing an effective date; and declaring an emergency.

HB 2773 – By Pfeiffer of the House and Weaver of the Senate.

Supp. 2020, Section 1622), which relates to mortgage on real estate; modifying percentages of company's admitted assets that may be invested in certain mortgage loans, money mortgages and real property; providing exception; calculating portfolio average loan to value; amending 36 O.S. 2011, Section 1624, as amended by Section 4, Chapter 287, O.S.L. 2017 (36 O.S. Supp. 2020, Section 1624), which relates to acquiring or holding real property; modifying percentage of company's admitted assets that may be invested in real property; and providing an effective date.

An Act relating to revenue and taxation; enacting the Oklahoma Remote Quality Jobs Incentive Act; stating legislative intent; defining terms; providing for payment of incentive amounts; providing for computation of incentive payment amounts; prescribing procedures for applications and incentive payments; imposing restriction on eligibility dates for
