## **Statewide Overview**

### **Population**

Total Statewide Population – 3,932,870

Ideal district size for each State Senate Seat – 81,935

Total Deviation – 3.84% - SD 48 is +1.97 over and SD 23 is -1.87% over (allowed deviation per rules passed by the committee was 5%)

28.63% of the citizens of Oklahoma will live in a new Senate District

### **Compactness**

54 counties remain whole (current map has 51 counties remain whole)

6 counties split 3 or more times – Oklahoma, Tulsa, Canadian, Cleveland, Wagoner, and Cherokee (current map splits 10 counties 3 or more times)

SD 1 is the most overall compact district in the State

Compactness scores below come from Maptitude

**CUTS AND EDGES** – a smaller number implies a more compact plan.

New map – 9,226 cuts and edges      Current map – 10,001 cuts and edges

**REOCK** – The Reock test is an area-based measure that compares each district to a circle, which is considered the most compact shape possible. For each district, the Reock test computes the ratio of the area of the district to the area of the minimum enclosing circle for the district. Number closer to 1 is the most compact.

New Map – Mean score of .42      Current map – Mean score of .41

**POLSBY- POPPER** – The Polsby-Popper test computes the ratio of the district area to the area of a circle with the same perimeter. With 1 being the most compact.

New Map – Mean score of .39

Current Map – Mean score of .36

**AREA/CONVEX HULL** – The area/convex hull test computes the district area to the area of the convex hull of the district (minimum convex polygon which completely covers the district). With 1 being the most compact.

New Map – Mean score of .78

Current Map – Mean score of .73

**SCHWARTZBERG** – The Schwartzberg test computes the ratio of the perimeter of the simplified version of the district to the perimeter of a circle with the same area as the original district. The district is simplified by only keeping those shape points (trijunctions) where three or more areas in the base layer come together. Water features and neighboring areas also count as base layer areas. With 1 being the most compact

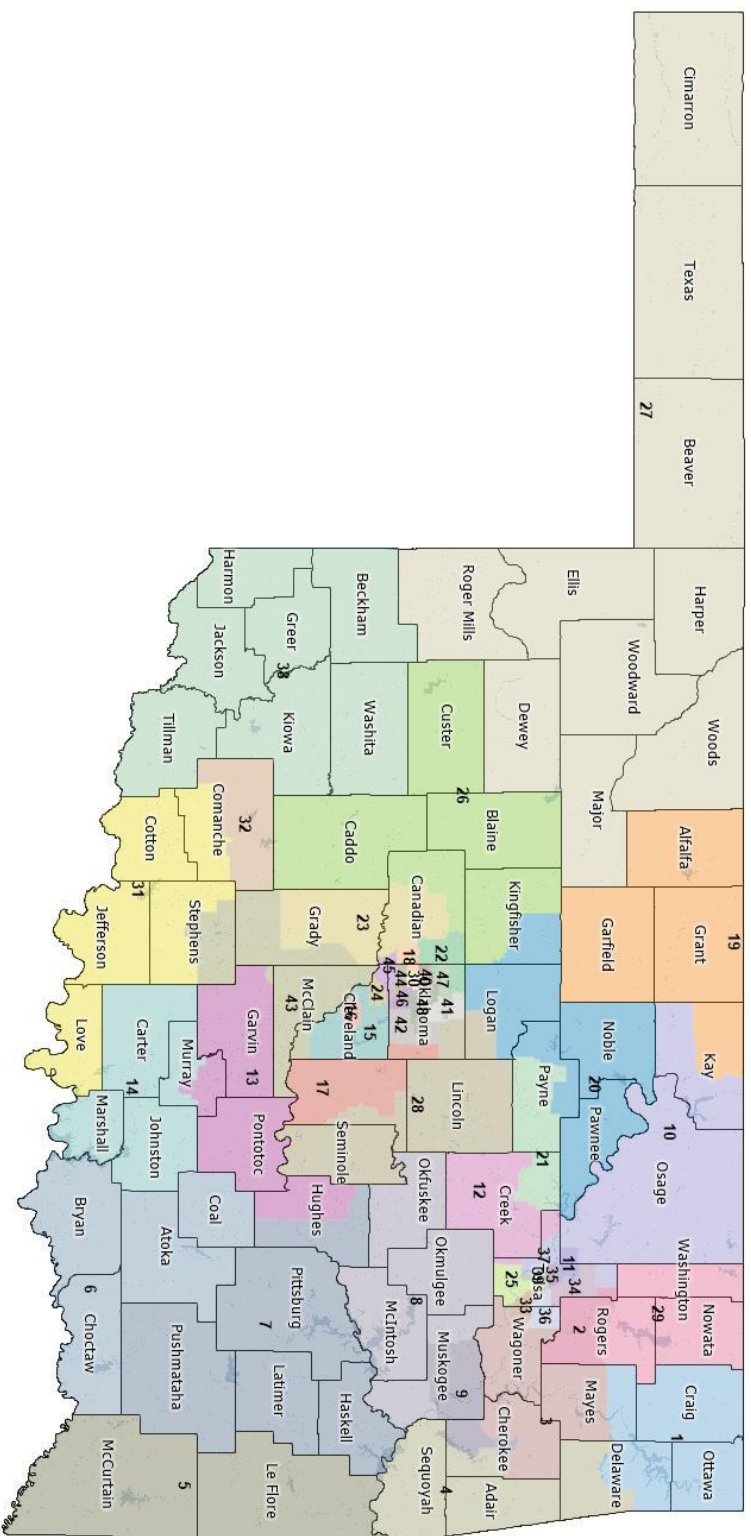

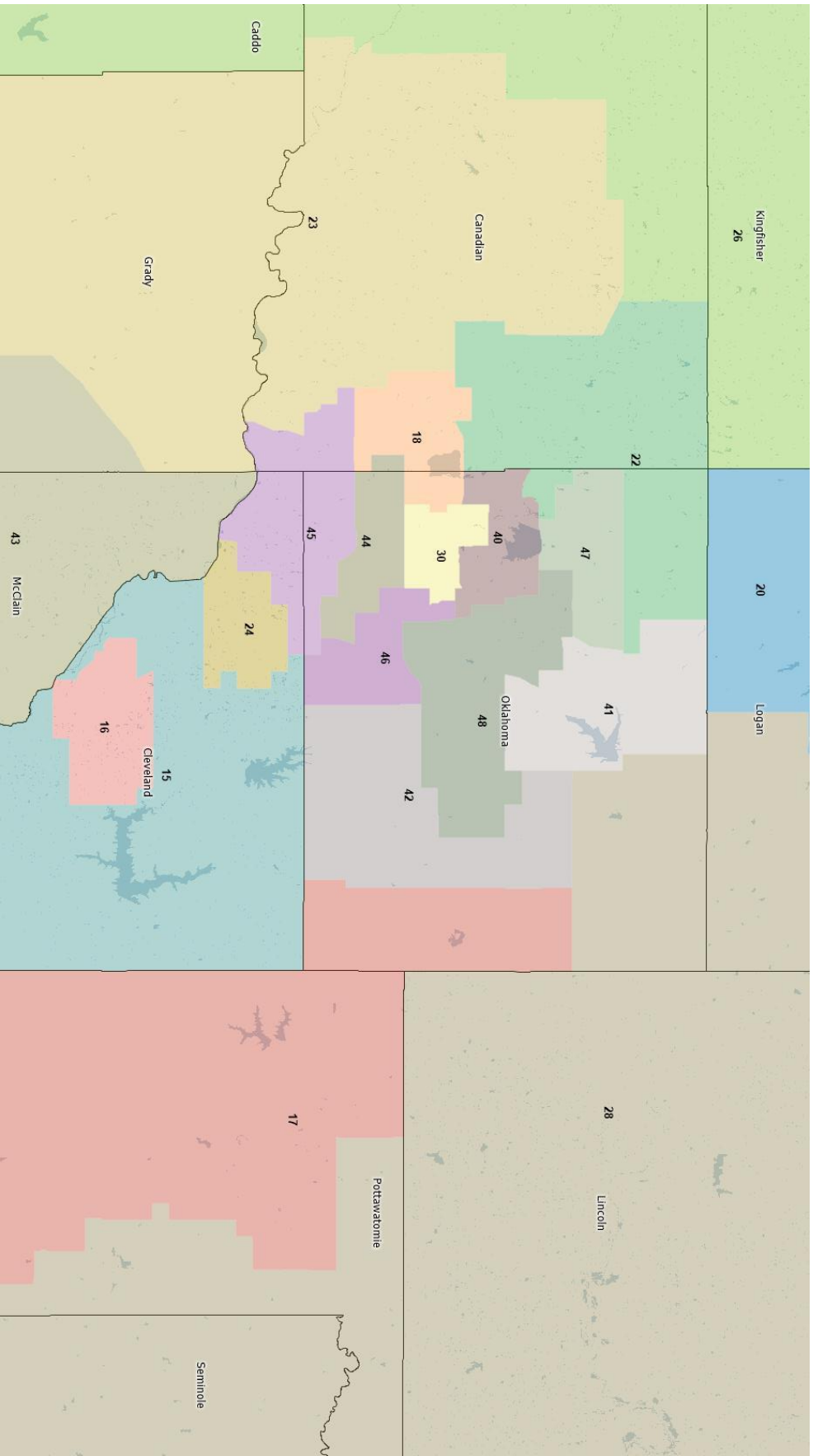
**POPULATION POLYGON TEST** – The population polygon test computes the ration of the district population to the approximate population of the convex hull of the district (minimum convex polygon which completely contains the district). The population of the convex hull is estimated by overlaying it with a base layer, such as Census Blocks. With 1 being the most compact.

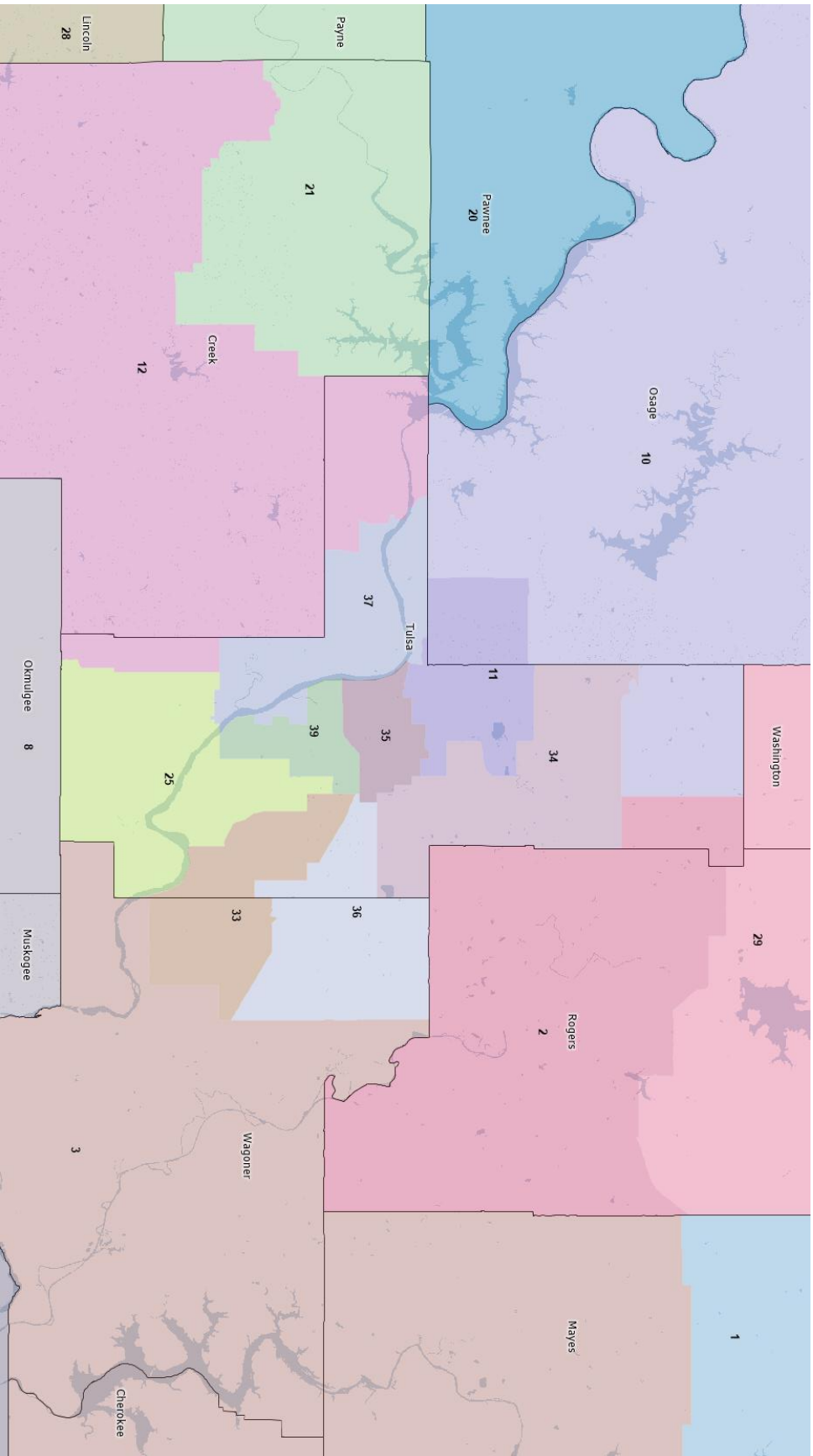

Subject: Additional Oklahoma Senate Seat in Oklahoma City Metro Area

On behalf of the Greater Oklahoma City Chamber, an economic development organization with more than 3,500 members, I am writing to express our organization's stance that the dynamic population and economic growth within our region merits the creation of a new Oklahoma City area district/seat within the Oklahoma Senate.

While population growth has been experienced in many areas of our region in recent years, I would like to highlight one specific area: the western portions of Oklahoma City located within Oklahoma and Canadian Counties. For example, between 2010-2019 Canadian County had the highest growth in the state at 28.4%. With 58,475 residents, Oklahoma City is the largest community in that county and experienced three times as much growth there in the past decade as in Oklahoma or Cleveland Counties. This area includes one of the state's five largest school districts, Mustang, and tremendous ongoing residential development. This area also represents a tremendous opportunity for future economic growth, given its prime location for business location and expansion.

Additionally, there is a strong private sector presence in this area of Oklahoma City given the impressive growth along the John Kilpatrick Turnpike (JKT) corridor that has only accelerated in the past decade. To take one example, in 2011 Paycom moved into a new 90,000 square foot office building located off the JKT. By 2020, Paycom's headquarters had grown to 500,000 square feet and the company employed an estimated 5,000. Many of these employees live and work in this area as contributors to continued growth.

These examples are just a snapshot of a growing region that boasts the 25<sup>th</sup> largest city in the United States, and the state's largest single site employer at Tinker Air Force Base with over 26,000 employees. Our region continues to make tremendous strides in key industries such as aerospace, back-office firms, and distribution.

As you continue your critical work to properly balance political representation across the state, the Chamber would like to take this opportunity to respectfully emphasize our belief that the addition of a new Oklahoma Senate member from the Oklahoma City metro is warranted and equitable given the successes highlighted above and ongoing potential for growth. Thank you for your tremendous efforts on behalf of Oklahomans.
