GENERAL ORDER

SB 1066 by Treat and Paxton of the Senate and McCall of the House was called up for consideration.

Senator Kirt moved to amend **SB 1066**, Page 599, Line 5½, by inserting a new SECTION 8 to read as follows, by renumbering subsequent section and amending the title to conform:

“SECTION 8. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:

The anticipated date of the United State Census Bureau’s release of the 2020 Federal Decennial Census data provided for in P.L. 94-171 is on or about August 2021. Upon receipt of the P.L. 94-171 data, the Oklahoma State Senate shall review such data along with the provisions of this act. In the event the district lines herein require adjustments for compliance with the Constitution of this state or the Constitution of the United States, the Oklahoma State Senate shall make the necessary adjustments pursuant to legislative action.”, which amendment was declared adopted.

Senator Paxton moved that **SB 1066** be advanced, which motion was declared adopted.

An Act relating to higher education; amending 70 O.S. 2011, Section 3213, as amended by Section 627, Chapter 304, O.S.L. 2012 and Section 1, Chapter 252, O.S.L. 2012 (70 O.S. Supp. 2020, Sections 3213 and 3213.2), which relate to the University Center of Southern Oklahoma; renaming University Center of Southern Oklahoma; transferring control of certain funds and accounts; designating the Board of Regents of Murray State College as the administrative agency; dissolving certain board of trustees; updating references to name; amending 70 O.S. 2011, Section 3407.2, which relates to the Board of Regents of Murray State College; updating Board name; modifying membership of the Board; transferring the University Center of Southern Oklahoma to Murray State College;

listing items included in the transfer; transferring title to buildings, improvements and real property; providing for codification; and declaring an emergency.
