MESSAGE FROM THE GOVERNOR

Advising his veto May 11, 2021, of Enrolled SB 222.

The veto message reads as follows:

May 11, 2021

To the Honorable President Pro Tempore And Members of the Oklahoma Senate First Session of the Fifty-Eighth Oklahoma Legislature

ENROLLED SENATE BILL NO 222:

Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Senate Bill 222.

Senate Bill 222 would greatly expand the definition of "bullying." While the intentions behind this expansion are understandable, the potential for unintended consequences is considerable. Given that many school districts have "zero tolerance" policies in place for bullying, relatively minor offenses could be met with disproportionate consequences. Further, the practically catch-all nature of the expanded definition opens the door to innocent behavior being treated as "bullying" by overzealous authorities. Serious bullying demands our attention and must be addressed. Senate Bill 222, by broadening this definition in such a fashion, risks diverting attention from protecting those most in need of care.

For these reasons, I have vetoed Senate Bill 222.
