## First Extraordinary Session of the Fifty-eighth Legislature of the State of Oklahoma

**Fifth Legislative Day, Friday, November 19, 2021**

The Senate was called to order by Senator Howard.

Senator Howard declared a quorum present.

The prayer was offered by Senator Frank Simpson.

### REQUEST TO RECESS

Senator McCortney moved to request the Honorable House to consent to the adjournment of the Senate in the First Extraordinary Session of the 58<sup>th</sup> Legislature for a period of more than three days, pursuant to Article 5, Section 30 of the Oklahoma Constitution beginning on Friday, November 19, 2021 and ending on Friday, November 26, 2021, which motion was declared adopted.

### GENERAL ORDER

**HB 1001** by McCall and Martinez of the House and Treat and Paxton of the Senate was called up for consideration.

Senator Paxton moved that **HB 1001** be advanced, which motion was declared adopted.

**THIRD READING**

**HB 1001** was read for the third time at length.

On the question of passage of the bill, the vote resulted as follows:

**GENERAL ORDER**

**HB 1002** by McCall and Martinez of the House and Treat and Paxton of the Senate was called up for consideration.

### **GENERAL ORDER**

**HCR 1001** by McCall of the House and Treat of the Senate was called up for consideration.

**HCR 1001** was adopted upon motion of Senator Treat and properly signed and ordered returned to the Honorable House.

A Concurrent Resolution relating to sine die adjournment.

WHEREAS, the Governor issued Executive Order No. 2021-021 on September 24, 2021, convoking the First Extraordinary Session of the 58th Oklahoma Legislature for assembly on November 15, 2021; and

WHEREAS, the Oklahoma House of Representatives and the Oklahoma State Senate anticipate that all required actions on legislation during such First Extraordinary Session will be complete by the end of the day on November 26, 2021; and

WHEREAS, to provide for orderly adjournment of the First Extraordinary Session of the 58th Oklahoma Legislature the two chambers concur that sine die adjournment should occur no later than 11:59 p.m. on November 26, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 1ST EXTRAORDINARY SESSION OF THE 58TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the sine die adjournment of the First Extraordinary Session of the 58th Oklahoma Legislature shall be set no later than 11:59 p.m. on Friday, November 26, 2021, and unless an earlier sine die adjournment occurs the First Extraordinary Session of the 58th Oklahoma Legislature shall be adjourned, sine die, at 11:59 p.m., Friday, November 26, 2021.

Pursuant to the McCortney motion, the Senate adjourned at 11:25 a.m.
