Project Purpose	The objective of this proposal is to request funding for Business Continuity functions. A Disaster Recovery plan and site is imperative in regaining functionality to the Court's computer infrastructure after events like a natural disaster, cyber-attack, or business disruptions related to the COVID-19 pandemic. This would include systems such as the Court's case management, e-Citations, jury management, credit card processing, remote court hearing process, etc. in conjunction with data exchanges with external business sources such as Tyler Technologies, KellPro, Oklahoma Highway Patrol, and District Attorney's Council. The goal is to ensure the Judges and Court Clerks are able to provide the county courthouses with consistent and reliable data access for its employees and the constituents of the seventy-seven counties within Oklahoma.
