October 5, 2022

The Honorable President Pro Tempore And Members of the Oklahoma Senate Second Session of the Fifty-eighth Oklahoma Legislature

ENROLLED SENATE BILL NO. 18XX:

Pursuant to the authority vested in me by Section 12 of Article VI of the Oklahoma Constitution to approve or disapprove any appropriation bills, or any item therein contained, I have vetoed Enrolled Senate Bill 18xx.

Enrolled Senate Bill 18xx would appropriate to the Oklahoma Arts Council \$10,000,000.00.

I support the Oklahoma Arts Council, including its management and care of the State Art Collection, but the long-term, strategic value of this appropriation has not been clearly established.

Furthermore, nearly every industry across the state was adversely impacted by COVID-19, especially service industries like restaurants and small, local businesses These one-time funds present a unique opportunity to have a generational impact and leave a legacy for generations. It is preferable that these funds be used for infrastructure and water projects and long-term strategic investments that will change the trajectory of our state.

For this reason, I have vetoed Enrolled Senate Bill 18xx.
