## First Regular Session of the Fifty-ninth Legislature of the State of Oklahoma

Ninth Legislative Day, Thursday, February 16, 2023

The Senate was called to order by Senator Coleman.

Senator Bergstrom moved to amend **SB 515**, Page 18, Line 22, by striking after the word “Senate” and before the word “establish” the word “shall”, and inserting in lieu thereof the word “may”, which amendment was declared adopted.

Senator Bergstrom moved that **SB 515** be advanced, which motion was declared adopted.

**GENERAL ORDER**

Senator McCortney moved to amend **SB 840**, Page 4, Line 19, by deleting all new language and inserting in lieu thereof the words "a collegiate athletics association and institutional policy", which amendment was declared adopted.

Senator McCortney moved that **SB 840** be advanced, which motion was declared adopted.
