Advising passage of and transmitting for consideration Engrossed **HBs 1345, 1404, 1597, 1709, 1759, 2852, 2864, 2868** and **2882**.

HB 1345 – By Banning and Waldron of the House and Newhouse of the Senate. An Act relating to professions and occupations; authorizing issuance of license by reciprocity; amending 59 O.S. 2021, Section 1366, which relates to the Psychologists Licensing Act; providing for issuance of license by reciprocity; and providing an effective date.

HB 1404 – By Culver, Hardin and Humphrey of the House and Prieto of the Senate. An Act relating to firearms; amending 63 O.S. 2021, Section 4210.3, which relates to the Oklahoma Boating Safety Regulation Act; modifying scope of certain unlawful act; removing mandatory minimum penalties; deleting provision concerning the transport of handguns by licensees; and providing an effective date.

HB 1597 – By Martinez and Dollens of the House and Newhouse of the Senate. An Act relating to contracts; amending 15 O.S. 2021, Section 765.6, which relates to Notice of Opportunity to Repair Act; subjecting requirements to certain contractual agreements; and providing an effective date.

HB 1709 – By Marti of the House and Garvin of the Senate.

An Act relating to Advanced Practice Registered Nurses; defining terms; increasing the number of SoonerCare patients Advanced Practice Registered Nurses can provide care for; providing exception; providing for codification; and declaring an emergency.

HB 1759 – By Manger of the House and Stanley of the Senate.

An Act relating to excise tax; amending 68 O.S. 2021, Section 2105, which relates to excise tax on vehicles; modifying name of responsible entity; defining term; updating statutory language; providing for transfer-on-death procedures for vessels or motors; requiring notice; prescribing content of notice; authorizing revocation; providing for affidavit by transferee; providing for codification; and providing an effective date.

HB 2852 – By Wallace of the House and Weaver of the Senate.

An Act relating to fuel theft deterrence; creating the Bulk Fuel Transportation and Inspection Act; defining terms; requiring compliance with certain conditions and procedures related to transporting bulk fuels; creating felony for violation; establishing range of punishment; clarifying intent and application of the act; creating the Fuel Pump Security Act; defining terms; prohibiting certain acts; creating felonies for violations; establishing range of punishment; providing for codification; and providing an effective date.

HB 2864 – By Wallace of the House and Bullard of the Senate.

An Act relating to mental health; creating the Mental Health Transport Revolving Fund; establishing fund characteristics; authorizing expenditure of funds; providing procedures for expenditures; amending 43A O.S. 2021, Section 1-110, which relates to law enforcement responsibility for transporting persons for mental health services; limiting transportation to certain area under certain condition; requiring transportation responsibility of specified entities; modifying definition; providing for codification; and providing an effective date.

HB 2868 – By Wallace of the House and Green of the Senate.

An Act relating to wildlife; amending 29 O.S. 2021, Section 4-112, as amended by Section 1, Chapter 347, O.S.L. 2022 (29 O.S. Supp. 2022, Section 4-112), which relates to hunting licenses; modifying licenses authorization; and providing an effective date.

HB 2882 – By Wallace and Martinez of the House and Thompson (Roger) and Hall of the Senate.

An Act relating to the Commissioners of the Land Office; making an appropriation; identifying source; establishing amount and purpose; providing for noncodification; and declaring an emergency.
