Twenty-fifth Legislative Day, Tuesday, March 21, 2023

SB 475 by Paxton of the Senate and Echols of the House was called up for consideration.

Senator Paxton moved to amend **SB 475**, Page 24, Line 16½, by inserting a new Section 2 as follows:

“SECTION 2. AMENDATORY 63 O.S. 2021, Section 2-110, is amended to read as follows:

Section 2-110. The Director of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control may employ attorneys, who shall be unclassified employees of the state, or contract with attorneys, as needed. These attorneys may advise the Director, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control Commission and Bureau personnel on all legal matters and shall appear for and represent the Director, the Commission and Bureau personnel in all administrative hearings and all litigation or other proceedings which may arise in the discharge of their duties. At the request of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control Commission, such attorney shall assist the district attorney or the Attorney General in prosecuting charges of violators of the Uniform Controlled Dangerous Substances Act or any felony relating to or arising from a violation of the Uniform Controlled Dangerous Substances Act. Attorneys for the Bureau who have been certified by the Council on Law Enforcement Education and Training to carry a weapon or have been issued a handgun license pursuant to the provisions of the Oklahoma Self-Defense Act shall be allowed to carry weapons pursuant to paragraph 3 of subsection A of Section 1272 of Title 21 of the Oklahoma Statutes. These attorneys, pursuant to this provision, shall not be considered eligible to participate in the Oklahoma Law Enforcement Retirement System. If a conflict of interest would be created by such attorney representing the Director, the Commission or Bureau personnel, additional counsel may be hired upon approval of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control Commission.”; and by renumbering subsequent sections, which amendment was declared adopted.

An Act relating to criminal procedure; amending 22 O.S. 2021, Sections 34.1 and 34.2, which relate to the use of excessive force by peace officers; clarifying standard by which excessive force is measured; defining term; modifying elements of certain defined term; deleting requirement to adopt excessive force policies or guidelines; directing law enforcement entities to adopt policies or guidelines concerning the use of force; and providing an effective date.
