Second Regular Session of the Fifty-ninth Legislature of the State of Oklahoma Eighth Legislative Day, Thursday, February 15, 2024

An Act relating to public finance; amending 62 O.S. 2021, Section 34.42, which relates to budget work programs; requiring executive officer to certify agency compliance with certain requirements; and providing an effective date.

HB 3756 – By Hardin of the House and Woods of the Senate.

An Act relating to agriculture; amending 2 O.S. 2021, Sections 20-25 and 20-61, which relate to animal feeding operations; eliminating certain point system; and providing an effective date.
