MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 2190, 2955, 2957, 2958, 3034, 3050, 3196, 3232, 3763, 4064** and **4070**.

HB 2190 – By Lowe (Dick) of the House and Pemberton of the Senate.

An Act relating to schools; permitting board of education to establish fund to purchase high-deductible property insurance policy; requiring transfer of monies from school district general fund; prescribing maximum amount of transfer; providing for codification; providing an effective date; and declaring an emergency.

HB 2955 – By Kendrix of the House and Bergstrom of the Senate.

An Act relating to sunset; amending 59 O.S. 2021, Section 858-201, which relates to the Oklahoma Real Estate Commission; removing the Commission from the Oklahoma Sunset Law.

HB 2957 – By Kendrix of the House and Bergstrom of the Senate.

An Act relating to sunset; amending 74 O.S. 2021, Section 4102, which relates to the State Capitol Preservation Commission; removing the Commission from the Oklahoma Sunset Law.

HB 2958 – By Kendrix of the House and Bergstrom of the Senate.

An Act relating to sunset; amending 59 O.S. 2021, Section 624, which relates to the State Board of Osteopathic Examiners; removing the Board from the Oklahoma Sunset Law.

HB 3034 – By Stinson of the House and Pugh of the Senate.

An Act relating to schools; creating the Emerson Kate Cole Act; amending 70 O.S. 2021, Section 1-116.3, which relates to school medication policies; requiring school to call 911 if Epinephrine is administered to a student; mandating school to notify parent if student experiences possible allergic reaction; requiring annual training for certain teachers and school employees; prescribing content and method for training; providing for noncodification; providing an effective date; and declaring an emergency.

HB 3050 – By Boles of the House and Green of the Senate.

An Act relating to petroleum storage tanks; amending 17 O.S. 2021, Section 310, which relates to inspections and investigations; modifying time frame for appeal; removing certain statutory references; and providing an effective date.

HB 3196 – By Newton and Archer of the House and Jech and Pederson of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2021, Section 698.33, which relates to the Oklahoma Veterinary Practice Act; modifying veterinary training program for rural Oklahoma; updating references; prioritizing students currently enrolled at the Oklahoma State University College of Veterinary Medicine; modifying maximum assistance amount; and declaring an emergency.

HB 3232 – By Lawson, Waldron, Menz, Archer and Sims of the House and Gollihare of the Senate.

An Act relating to Route 66; amending Section 1, Chapter 412, O.S.L. 2022 (69 O.S. Supp. 2023, Section 4040), which relates to the Oklahoma Route 66 Commission; removing expiration date of the Oklahoma Route 66 Commission; amending Section 2, Chapter 412, O.S.L. 2022 (69 O.S. Supp. 2023, Section 4041), which relates to the Oklahoma Route 66 Commission Revolving Fund; modifying conditions for budgeting and expenditures of funds; and providing an effective date.

HB 3763 – By Cantrell and Sims of the House and Stewart of the Senate.

An Act relating to burn bans; amending 2 O.S. 2021, Section 16-26, which relates to emergency drought conditions and burning prohibitions; directing that fire departments and county officials shall be allowed to place burn ban signage on certain Oklahoma Department of Transportation signposts; directing parties to work on agreed locations; directing the Oklahoma Department of Transportation to develop standards; clarifying responsibility for signage; directing that the view of traffic not be blocked; clarifying responsibility for cost of signage; and providing an effective date.

HB 4064 – By Wallace of the House and Hall of the Senate.

An Act relating to public finance; creating the Oklahoma Small Business Expansion and Jobs Act; defining terms; authorizing certain uses of certain funds; requiring certain actions prior to loan administration; requiring the development of a revolving loan program; requiring certain program criteria and processes; requiring certain quarterly reporting; prohibiting certain actions; creating the Small Business Expansion Revolving Fund; establishing the fund under the Oklahoma Center for the Advancement of Science and Technology; establishing revolving fund characteristics; authorizing and limiting expenditure and budgeting of funds; creating accounts within the fund; providing for allocation of fund balance among the accounts; authorizing opt-in feature to program; providing opt-in process; providing for the promulgation of rules; providing for codification; providing an effective date; and declaring an emergency.

HB 4070 – By Wallace and Sims of the House and Hall of the Senate.

An Act relating to county economic development; creating the Rural County Economic Development Act of 2024; authorizing certain reference; authorizing the creation of County Economic Development Organization; providing process and parameters of formation; establishing limited purposes; providing for appointment and organization of Organization members; establishing eligibility criteria; prohibiting compensation; authorizing certain reimbursement; authorizing certain actions; providing and limiting certain powers; authorizing certain delegation of powers and duties; authorizing certain contracting; authorizing certain county-option sales tax levy; limiting levy; requiring submission to voters at special election; requiring certain fund creation and accounting; providing for codification; and providing an effective date.
