Second Regular Session of the Fifty-ninth Legislature of the State of Oklahoma Sixteenth Legislative Day, Thursday, February 29, 2024

Senator McCortney moved to amend **SB 1390**, Page 13, Line 16, by deleting after the word "than" and before the word "and", the words and numbers "One Thousand Dollars (\$1,000.00)" and inserting in lieu thereof the words and numbers "One Hundred Dollars (\$100.00)"; and Page 14, Lines 20 and 21, by deleting all new language and restoring the stricken language, which amendment was declared adopted.

HB 2562 – By McBride, Baker, Moore, West (Tammy), Fugate and Provenzano of the House and Murdock of the Senate.

An Act relating to schools; amending 70 O.S. 2021, Section 3-101, as amended by Section 1, Chapter 182, O.S.L. 2023 (70 O.S. Supp. 2023, Section 3-101), which relates to the State Board of Education; modifying membership of the Board; requiring Senate confirmation for certain appointments; providing for members to serve at the pleasure of the appointing authority; directing vacancies to be filled by the appointing authority; providing for initial appointments within specified time; establishing termination date for initial appointments; and providing an effective date.

HB 3462 – By Archer and Moore of the House and Green of the Senate.

An Act relating to live game; creating the Chronic Wasting Disease Genetic Improvement Act, providing for reference; requiring creation of certain pilot program by certain date; establishing program's purpose to enhance genetic durability of Oklahoma deer against chronic wasting disease; establishing program at the Department of Agriculture, Food, and Forestry; requiring certain assistance of the Oklahoma Department of Wildlife; requiring collection of DNA samples; requiring certain procedures and determinations; requiring program be administered in quadrants of the state; providing for the establishments of quadrants; limiting participation in program; providing for certain timeline of program activity; authorizing the promulgation of rules; providing for a one time permit fee; and providing an effective date.

HB 3560 – By Kendrix of the House and Daniels of the Senate.

An Act relating to public finance; amending 62 O.S. 2021, Section 34.10, which relates to annual reporting requirements; modifying description of certain report; providing an effective date; and declaring an emergency.

The above-numbered measures were read the first time.
