**Seventeenth Legislative Day, Monday, March 4, 2024**

An Act relating to motor vehicles; 47 O.S. 2021, Section 1107, as last amended by Section 2, Chapter 366, O.S.L. 2023 (47 O.S. Supp. 2023, Section 1107), which relates to sale or transfer of ownership of a vehicle; setting time limit on certain impoundment of vehicles; allowing for dismissal of charges if certain conditions are met; amending 47 O.S. 2021, Sections 1137.1, as last amended by Section 1, Chapter 262, O.S.L. 2023, and 1137.3, as last amended by Section 2, Chapter 262, O.S.L. 2023 (47 O.S. Supp. 2023, Sections 1137.1 and 1137.3), which relate to used dealer temporary plate and registration and licensing of new motor vehicles; modifying description of certain length of time; and providing an effective date.

**HB 4097** – By Caldwell (Trey) of the House and Paxton of the Senate.

An Act relating to public utilities; amending 17 O.S. 2021, Section 291, which relates to definitions; modifying definition; amending 17 O.S. 2021, Section 292, which relates to rights of electric transmission owners; adding description of certain electric transmission facility; authorizing certain rights to incumbent electric transmission owners for certain facilities; requiring solicitation of competitive bids for construction of certain facilities; requiring certain request for proposal and bid evaluation to be overseen by appointed independent evaluator; authorizing incumbent electric transmission owner to submit certain bid; amending 17 O.S. 2021, Section 293, which relates to local electric transmission facility; requiring certain notice of intent; and providing an effective date.

**HJR 1058** – By Lawson of the House and Bergstrom of the Senate.  
A Joint Resolution approving proposed permanent rules of the Oklahoma Route 66 Commission; and directing distribution.
