HB 2989 – By West (Josh) of the House and Stanley of the Senate.

An Act relating to higher education; amending 70 O.S. 2021, Section 3207.1, which relates to transfer of credits; modifying language regarding submission of certain report; stating legislative intent that certain institutions of higher education not require a score higher than certain recommended score on certain examination to grant certain course credit; allowing certain institution president to make certain determination; requiring institutions to post certain policy on campus websites; providing an effective date; and declaring an emergency.

HB 3015 – By Boatman of the House and Garvin of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2021, Section 1261.1, which relates to social worker licensing requirements; modifying certain schooling qualifications; and providing an effective date.

HB 3051 – By Boles, Hilbert and Williams of the House and Paxton of the Senate. An Act relating to revenue and taxation; amending 68 O.S. 2021, Section 2357.22, as last amended by Section 1, Chapter 215, O.S.L. 2023 (68 O.S. Supp. 2023, Section 2357.22), which relates to tax credits for investment in certain clean-burning motor vehicle fuel property; providing for reallocation of unused tax credits; prescribing method for reallocation; and providing an effective date.

HB 3158 – By Roberts, West (Tammy) and Wolfley of the House and Rader of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2021, Sections 199.7 and 199.14, which relate to the Oklahoma Cosmetology and Barbering Act; providing student entrance requirements; modifying fees; directing the payment of fees; providing for a waiver of fees for certain individuals; creating tax-exempt schools for cosmetology and barber training; providing for application form, initial license fee, surety bond, and financial statement; creating tax-exempt schools within the Department of Corrections; providing for letter of intent, application form, initial license fee, surety bond, financial statement, and proof of use of building; providing for tax-exempt license renewal; providing for application and fee; prohibiting deceptive or misleading language in advertising; requiring initial school building inspection requests to be filed with the State

Board of Cosmetology and Barbering; requiring certain building specifications for lighting, ventilation, floors, parking, safety codes, spacing, water dispensaries, and cleaning; mandating minimum school training equipment requirements; prescribing cosmetology course curriculum for private, public, and non-profit schools; specifying minimum training supplies required for cosmetology students; providing curriculum content and training requirements for cosmetology and barbering courses; prescribing requirements for instructors; requiring Board notification for staff changes; specifying minimum student attendance per week; mandating certain record creation, retention, and availability standards; requiring monthly submission of clock hour reports; requiring display of certain documents; requiring production of certain identification; providing for codification; and providing an effective date.

An Act relating to property; amending 60 O.S. 2021, Section 852, which relates to owners associations; requiring an owners association to adopt and comply with a document retention policy; providing minimum requirements; providing for injunctive relief; amending 59 O.S. 2021, Section 858-301, which relates to exemptions for license requirements; providing license requirement to engage in the management of an owners association; providing additional exemptions for license requirements; and providing an effective date.

An Act relating to schools; amending 70 O.S. 2021, Section 1210.508, which relates to the statewide system of student assessments; adding optional career-readiness and armed services assessments for certain students; requiring assessment to be administered at no cost to students; providing an effective date; and declaring an emergency.

HB 3428 – By Archer and McEntire of the House and Kirt of the Senate.

An Act relating to tattoo and body piercing; amending 21 O.S. 2021, Section 842.3, which relates to license requirements, rules, regulations, and penalties; modifying mandatory rules; removing license requirements; adding enforcement authority to the State Department of Health; providing enforcement authority to Attorney General and district attorneys; providing venue; and providing an effective date.

HB 3449 – By Boatman, Provenzano, Alonso-Sandoval and Deck of the House and Haste of the Senate.

An Act relating to mental health workforce development; amending Section 1, Chapter 112, O.S.L. 2023 (63 O.S. Supp. 2023, Section 3278.1), which relates to Oklahoma State University Medical Authority Behavioral Health Workforce Development Fund; creating a revolving fund for the University Hospitals Authority and Trust; providing purpose of pilot program; and declaring an emergency.
