# Second Regular Session of the Fifty-ninth Legislature of the State of Oklahoma Forty-fifth Legislative Day, Wednesday, April 24, 2024

All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Office of Management and Enterprise Services for the purpose provided for in this section. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment."; and renumbering subsection sections; and by amending the title to conform, which amendment was declared adopted.

Senator Stanley moved that **HB 4012** be advanced, which motion was declared adopted.
