Second Regular Session of the Fifty-ninth Legislature of the State of Oklahoma

Fifty-sixth Legislative Day, Tuesday, May 14, 2024

The Senate was called to order by Senator Daniels.

MESSAGES FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 2912** and **2913**.

HB 2912 – By Wallace, Munson, Caldwell (Trey), Townley and Strom of the House and Hall and Rosino of the Senate.

An Act relating to emergency management; creating the State Assistance Dedicated for Disaster-impacted Local Economies Revolving Fund; establishing revolving fund characteristics; declaring funds appropriated; providing purpose; providing expenditure procedures; defining terms; authorizing the promulgation of rules; providing for codification; and declaring an emergency.

HB 2913 – By Wallace, Caldwell (Trey), Townley and Strom of the House and Hall and Rosino of the Senate.

An Act relating to emergency management; appropriating disaster and emergency management funding; identifying revolving funds; establishing amounts, sources, and purposes; providing for noncodification; and declaring an emergency.

The above-numbered measures were read the first time.

Advising concurrence in **SAs** to and passage of Engrossed **HB 1349**.

Advising fourth reading of and transmitting for signature Enrolled **HBs 2291, 3231, 3351, 3511, 3618 and 4148**.

The above-numbered enrolled measures were, after fourth reading, properly signed and ordered returned to the Honorable House.
