EXECUTIVE DEPARTMENT AMENDED EXECUTIVE ORDER 2024-10

To the Honorable Members of the Oklahoma State Senate:

I, J. Kevin Stitt, Governor of the State of Oklahoma, pursuant to the authority vested in me by Article VI, § 7 of the Oklahoma Constitution, hereby convoke the Senate only to convene for an Extraordinary Session of the Fifty-Ninth Legislature to occur at the State Capitol on June 12, 2024, and amend the call for only the following purpose to be acted upon:

To provide the Senate's advice and consent for the Governor's appointment of Jennifer Callahan as a member of the Board of Regents for the Oklahoma Agricultural and Mechanical Colleges, to serve an eight-year term, succeeding Rick Davis, pursuant to Article VI, Section 3la of the Oklahoma Constitution.

Copies of this Amended Executive Order shall be distributed to every member of the Oklahoma State Senate and the Secretary of the Senate.
