MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HB 2728**.

HB 2728 – By Kendrix, Maynard, CrosswhiteHader, Lepak, Moore, Caldwell (Trey), Boles, Hill, Hildebrant, Steagall and Kane of the House and Bergstrom and Jett of the Senate.

An Act relating to administrative rule processes; enacting the Regulations from the Executive in Need of Scrutiny (REINS) Act of 2025; defining terms; imposing duties on agencies with respect to rules; prescribing procedures; requiring economic impact analysis; requiring consultation with political subdivisions; requiring solicitation of information from certain entities; establishing the Legislative Economic Analysis Unit within the Legislative Office of Fiscal Transparency; imposing duties with respect to analysis of rules; prescribing limit on full-time-equivalent employees; requiring independent analysis; requiring reports; requiring cooperation by state agencies; providing for evaluation of rules at request of certain officials; requiring public availability of information; requiring annual report; requiring quantification of certain results; prohibiting certain rule from taking effect without specific approval pursuant to legislative measure; providing for noncodification; providing for codification; and providing an effective date.
