MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1089, 1160, 1220, 1256, 1373, 1416, 1480, 1576, 1607, 1850, 2117, 2209, 2402, 2729** and **2802**.

HB 1089 – By Culver and Lowe (Dick) of the House and Kern of the Senate.

An Act relating to amusements and sports; amending 3A O.S. 2021, Section 267, which relates to horse racing; modifying what organization licensees shall negotiate and covenant; and providing an effective date.

HB 1160 – By Tedford of the House and Reinhardt of the Senate.

An Act relating to insurance; amending 36 O.S. 2021, Sections 2002, 2003, 2004, 2007, 2009, 2020.1, and 2020.2, which relate to the Oklahoma Property and Casualty Insurance Guaranty Association Act; modifying purpose; modifying applicability; modifying definitions; providing definitions; modifying the powers and duties of the Association; clarifying parties; clarifying timelines; permitting the Association to join certain organizations; permitting the Association to make certain payments; prohibiting use of the existence of the Association to sell or solicit insurance; clarifying that certain records are not public records; providing exceptions; providing for codification; and providing an effective date.

HB 1220 – By West (Kevin), Fugate, McCane, Roberts and Kendrix of the House and Standridge of the Senate.

An Act relating to securitization revenue stream of certain obligations issued by the Oklahoma Development Finance Authority pursuant to the February 2021 Regulated Utility Consumer Protection Act; and pursuant to the February 2021 Unregulated Utility Consumer Protection Act; making legislative findings with regard to matters of statewide concern; imposing restriction on certain municipalities with respect to franchise fees; imposing restriction on certain municipalities with respect to locally imposed taxes; providing for noncodification; providing for codification; and declaring an emergency.

HB 1256 – By Strom of the House and Thompson of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2021, Section 1000.4a, as amended by Section 3, Chapter 185, O.S.L. 2023 (59 O.S. Supp. 2024, Section 1000.4a), which relates to construction skilled trade education; modifying contract terms; and providing an effective date.

HB 1373 – By Boles and CrosswhiteHader of the House and Green of the Senate.

An Act relating to commercial solar facilities; creating the Commercial Solar Facility Decommissioning Act; defining terms; making certain agreement provisions void; providing for certain injunctive relief; stating certain provisions are not exclusive; requiring agreement contain certain provisions; requiring landowner make certain timely request; requiring certain financial assurance be delivered; stating acceptable forms of financial assurance; requiring certain amount of financial assurance; assigning certain costs to grantee; prohibiting certain cancellation of financial assurance; providing for codification; and providing an effective date.

HB 1416 – By West (Josh) and Fugate of the House and Rosino of the Senate.

[non-opioid treatment – preferred drug lists - coverage - United States Food and Drug Administration – reimbursement – codification - effective date]

HB 1480 – By West (Tammy), Pae, Osburn, Miller, Roberts and Hefner of the House and Gollihare of the Senate.

An Act relating to children; defining term; directing the court to determine ability to pay; providing that the ability to pay shall not impact disposition; providing that certain persons shall be relieved of debt if certain determination is made; providing factors court shall consider; providing factors court shall not consider; providing for presumption of inability to pay; directing court to inform certain persons of certain information; directing the court to provide cost hearing in certain situation; directing that percentage reduction apply to all financial obligations; directing court clerk to review cases; directing court clerk to notify court and set certain hearing in certain situation; directing court clerk to issue summons; providing information the summons shall contain; amending 10A O.S. 2021, Sections 2-3-101 and 2-3-103, as amended by Section 1, Chapter 242, O.S.L. 2022 (10A O.S. Supp. 2024, Section 2-3-103), which relate to the Oklahoma Juvenile Code; providing that youth shall not be responsible for detention costs; providing that no order shall be made requiring certain persons to pay expenses; providing for codification; and providing an effective date.

HB 1576 – By Lawson of the House and Hicks of the Senate.

[Medicaid - Oklahoma Health Care Authority - coverage – criteria – Health Information Portability and Accountability Act requirements - scientific research - waiver application – codification - effective date – emergency]

HB 1607 – By Gise, Pae, Hefner and Pittman of the House and Kern of the Senate.

An Act relating to state contract employees; directing state agencies report number of contract employees; requiring reports to include pay; directing for reports to be made through existing software; granting the Office of Management and Enterprise Services certain rulemaking authority; providing for codification; and providing an effective date.

HB 1850 – By Schreiber of the House and Howard of the Senate.

An Act relating to trusts; creating the Oklahoma Uniform Trust Code; providing scope of act; defining terms; providing when person or organization has knowledge of a fact; providing when this act governs the duties and power of trustee, relations among trustees,

and the rights and interests of a beneficiary; providing that terms of trust prevail over provisions of this act; providing exceptions; providing that the common law of trusts and principles equity supplement this act in most circumstances; providing what governing law applies for determining the meaning and effect of the terms of a trust; providing guidelines for the principal place of administration; providing methods of notices; providing for waiver of notice; providing for rules of construction the interpretation of and disposition of property by will also apply to the interpretation of the terms of a trust and the disposition of the trust property; defining term; providing for insurable interests of trustees; providing guidelines on who may receive an insurable interest of a trustee; providing the role of a court in administration of a trust; providing who shall have jurisdiction over the trust; providing for venue location for legal proceedings; providing that notice to certain representatives has the same effect as if notice were given directly to the other person; providing that consent by a representative is binding on the person they represent in certain circumstances; providing that a settlor may not represent and be a beneficiary in certain circumstances; providing representation power by a holder of general testamentary power of appointment; providing representation powers by fiduciaries and parents; providing for representation in certain instances by a person having substantiality identical interests; providing for appointment of a representative; providing power and duties of representative; providing methods of creating a trust; providing requirements for creating a trust; providing when a trust created in another state is valid; providing trust purpose; providing purpose of a charitable trust; providing a court select purpose or beneficiary for a charitable trust in certain circumstances; providing who may maintain a proceeding to enforce a charitable trust; providing that a trust is void if the creation was induced by fraud, duress, or undue influence; providing requirements for an oral trust; providing rules for noncharitable trust created without ascertainable beneficiary; providing when a trust terminates; providing who may commence a proceeding for the modification and termination of a trust; providing procedure for the modification or termination of a noncharitable irrevocable trust; providing that the court may modify or terminate a trust in certain circumstances; providing that a court may apply cy pres to modify or terminate charitable trust in certain circumstances; providing for modification or termination of uneconomic trusts in certain circumstances; providing for manner of distribution if uneconomic trust is terminated; providing trust that are exempt from modification or termination if they are uneconomical; providing that a court may reform a trust to correct certain mistakes; providing that a court may modify a trust to achieve a settlors tax objectives; providing that a trustee may combine multiple trusts into a single trust; providing that a trustee may divide a single trust into multiple trusts; providing that whether or not the terms the trust contain a spend thrift certain rules apply for creditors claim against a settlor; providing rules for a creditors claims against a settlor; providing required capacity of settlor of a revocable trust; providing power of settlor in a revocable trust; providing power of settlor has power of withdrawal for a revocable trust; providing limitations on actions contesting the validity of a revocable trust; providing for a beneficiary of a trust to return any distributions in certain circumstances; providing for accepting or declining of trusteeship; providing when a trustee is required to post a bond; providing procedures and requirements for co-trustees of a trust; providing when a vacancy in a trusteeship occurs; providing for appointment of successor trustees; providing procedure for the resignation of a trustee; providing for the removal of a trustee by the court; requiring former trustees to

deliver property held to a successor trustee; providing for compensation of trustees; providing for reimbursement of expenses by a trustee; providing duty of trustees to administer trust; providing for a duty of loyalty by a trustee; providing for impartiality by a trustee when a trust has more than one beneficiary; requiring a trustee to administer trust prudently; providing what costs a trustee may incur in administering the trust; requiring trustees who were selected because of a special skill or expertise to use such skill or expertise in administering the trust; providing that a trustee may delegate duties and powers; providing requirements for delegating duties and powers; providing that trustee shall take reasonable steps to take control of and protect the trust property; providing requirements for recordkeeping and identification of trust property by a trustee; requiring that a trustee shall take reasonable steps to enforce claim of the trust and to defend claims against the trust; requiring a trustee to collect trust property from former trustees and to redress a breach of trust committed by a former trustee; providing that a trustee has a duty to inform and make reports to certain individuals; providing trustee has certain discretionary powers; providing general powers of a trustee; providing specific powers of trustee; providing procedure and requirements for distribution of a trust upon termination; providing when a trustee is entitled to a contribution by a co-trustee; providing that a trustee is accountable to a beneficiary for any profit made by the trustee, even absent a breach of trust; providing that absent a breach of trust, a trustee is not liable to a beneficiary for a loss or deprivation in the value of the trust or for not making a profit; providing that a trustee is not liable for a breach of trust if reasonably relying upon the terms of the trust; providing that a trustee is not liable for certain events that occur that affect administration or distribution of a trust; providing limitation on personal liability of a trustee; providing that trustees who hold an interest as a general partner in a general or limited partnership is not personally liable for certain actions and events; providing that a trustee may provide a certification of trust in certain circumstances; providing requirements of a certification of trust; providing exemptions for a certification of trust may be used; providing requirements for electronic records and signatures; providing for severability of act for provisions that are held invalid; providing application to existing relationships; providing for codification; and providing an effective date.

HB 2117 – By Kannady of the House and Howard of the Senate.

An Act relating to civil procedure; enacting the Uniform Collaborative Law Act; defining terms; providing for applicability of act; specifying requirements of collaborative law participation agreements; providing for beginning and ending of collaborative law process; requiring notice; providing for termination with or without cause; providing for continuation of collaborative law process under certain conditions; providing for procedures before certain tribunals; prescribing procedures; providing for status report; providing for issuance of emergency orders; authorizing approval of certain agreements; providing procedures related to disqualification of attorneys; providing for representation without fees; providing standard for income qualifications; providing for disqualification of attorneys representing governmental entities; providing for disclosure of information related to collaborative matters; providing for inapplicability of act to certain professional standards; imposing duties on attorney with respect to collaborative law participation agreements; requiring certain inquiry related to coercive or violent relationships; prescribing procedures; providing for confidentiality; providing for privilege with respect to

collaborative law communications; providing for waiver of privilege; limiting scope of privilege; providing for authority of tribunal in case of noncompliance; providing for uniform application; providing for effect of act with respect to other laws; providing for codification; and providing an effective date.

An Act relating to the Oklahoma Open Meeting Act; allowing members of a public body to participate in a meeting from their private residence under certain circumstances; excluding private residences from location disclosure under certain circumstances; clarifying applicability; defining term; clarifying compliance requirements; stating legislative intent; providing for codification; and providing an effective date.

HB 2402 – By Fetgatter of the House and Murdock of the Senate.

[revenue and taxation - Oklahoma Advanced Manufacturing Incentive Act of 2025 - establishing time period - eligibility requirements - collaboration]

HB 2729 – By Kendrix, Maynard, Jenkins, Lepak, CrosswhiteHader, Stark and Hill of the House and Bergstrom of the Senate.

An Act relating to administrative law; amending 75 O.S. 2021, Section 318, which relates to judicial review; prohibiting deference to an agency's interpretation of a statute, regulation, or sub-regulatory document; prescribing a de novo review standard; requiring a reasonable interpretation limiting agency power in certain circumstances; and providing an effective date.

HB 2802 – By Marti of the House and Alvord of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2021, Section 4000.1, as last amended by Section 9, Chapter 227, O.S.L. 2024 (59 O.S. Supp. 2024, Section 4000.1), which relates to denying or disqualifying professional licenses or certifications; adding terms; and providing an effective date.
