HB 1017 – By Moore, Boles and Deck of the House and Rader of the Senate. An Act relating to college sports; enacting the Oklahoma College Athletic Conference Act; providing legislative intent; defining terms; establishing the Oklahoma NCAA Division II Athletic Conference Exploration Commission; providing for membership; providing for chairperson; requiring certain study to be conducted by commission; requiring submission of report; authorizing commission to contract with independent consultants; authorizing commission to consult NCAA; requiring submission of final report; creating the Oklahoma NCAA Division II Athletic Conference Exploration Commission Revolving Fund; authorizing certain expenditures; requiring commission to explore certain funding sources; providing for codification; and declaring an emergency.

An Act relating to the State Department of Health; creating the Barbara Weber Amyotrophic Lateral Sclerosis (ALS) Grant Program; placing the program at a certain agency; providing purpose; requiring certain reports; establishing the Barbara Weber Amyotrophic Lateral Sclerosis (ALS) Grant Program Revolving Fund; establishing fund nature; authorizing certain budgeting and expenditure of funds for certain purposes; providing for codification; providing an effective date; and declaring an emergency.

HB 1377 – By Dempsey, Fugate and Pittman of the House and Murdock of the Senate.

An Act relating to alcoholic beverages; amending 37A O.S. 2021, Section 6-103, as last amended by Section 1, Chapter 200, O.S.L. 2023 (37A O.S. Supp. 2024, Section 6-103), which relates to prohibited acts of retail spirits licensees; expanding exemption for offering or furnishing any prize, premium, gift, or similar inducement to a consumer in connection with the sale of alcoholic beverages for current or former members of the United States Armed Forces; amending 37A O.S. 2021, Section 6-108, which relates to prohibited acts of holders of retail wine or retail beer licenses; expanding exemption for offering or furnishing any prize, premium, gift, or similar inducement to a consumer in

connection with the sale of beer or wine for current or former members of the United States Armed Forces; and providing an effective date.

HB 1390 – By Provenzano of the House and Coleman of the Senate.

An Act relating to the Oklahoma Child Care Facilities Licensing Act; amending 10 O.S. 2021, Section 406, which relates to investigations; directing that report remain available; and providing an effective date.

HB 1542 – By Patzkowsky of the House and Pederson of the Senate.

An Act relating to agriculture; amending 2 O.S. 2021, Sections 14-2 and 14-3, which relate to weights and measures; removing the requirement to send reference standards to the National Institute of Standards and Technology; providing that standards may be sent to a qualified laboratory; removing the requirement to have weights and measures certified by the National Institute of Standards and Technology; providing that a qualified laboratory may certify weights and measures; and providing an effective date.

HB 1588 – By Hardin, Deck and Alonso-Sandoval of the House and Woods of the Senate.

An Act relating to the Oklahoma Conservation Commission; creating the Spring Creek Watershed Study Act; establishing legislative intent; directing Conservation Commission to undertake certain water quality plan; requiring report; providing for cooperation with certain third parties; authorizing the acceptance of certain funds; creating the Spring Creek Watershed Study Cash Fund Revolving Fund; establishing fund purpose; providing source of funds; providing for codification; and providing an effective date.

HB 1663 – By Cantrell of the House and Frix of the Senate.

An Act relating to revenue and taxation; amending 68 O.S. 2021, Sections 3113, 3125, 3127, and 3129, as amended by Section 1, Chapter 178, O.S.L. 2023 (68 O.S. Supp. 2024, Section 3129), which relate to procedures for sale of property for unpaid ad valorem taxes; modifying provisions related to time for redemption of property; prescribing procedures related to online auctions; providing for effect of certain errors related to information related to tax sale process; modifying provisions related to method of payment; authorizing online sale process; prescribing procedures for online sale process; and providing an effective date.
