"place of worship" means any permanent building, structure, facility, or office space owned, leased, or rented on a full-time basis, and used weekly for worship services, activities, or business of the religious organization, which shall include, but not be limited to, churches, temples, synagogues, and mosques"; and
- Page 5, Line 21, by inserting after the letter "H.", and before the word "The", the number "1."; and
 - Page 6, Line 24 1/2, by inserting a new paragraph 2 to read as follows:
- "2. On and after the effective date of this act, if any place of worship is established within three thousand (3,000) feet of any retail marijuana grower after a license has been issued by the Authority for that location, the setback distance between properties shall not apply as long as the licensed property is used for its original licensed purpose. The licensed location shall be grandfathered in as to the setback distance as long as the property is used in accordance with the original licensed purpose"; and by amending the title to conform, which amendment was declared adopted.

An Act relating to insurance; amending 36 O.S. 2021, Section 3606, which relates to the capacity of minors to contract for insurance; requiring parental or guardian consent; providing immunity from certain liability; and providing an effective date.

An Act relating to education; amending 70 O.S. 2021, Section 6-204.2, which relates to the Education Leadership Oklahoma program; updating references; clarifying award

coverage; increasing maximum amount of award; changing conditions for repayment; authorizing reimbursement under certain conditions; expanding certain mentor program; and providing an effective date.

HB 2151 – By Hall of the House and Sacchieri and Jett of the Senate.

An Act relating to education; creating the Federal Education Guidance Disclosure Act; requiring the State Department of Education to publish certain documents on a website; prescribing publication timeframe; construing website creation timeline; mandating use of hyperlinks; directing retention of certain rescinded documents; stating retention requirements; defining term; providing for codification; and providing an effective date.

HB 2263 – By Miller and Luttrell of the House and Gollihare of the Senate.

An Act relating to motor vehicles; defining terms; making certain use of cellular telephones and electronic devices unlawful on certain stretches of road; creating penalty for violation; making certain exceptions; authorizing municipalities to enact certain ordinances; providing details for certain ordinances; requiring the Department of Public Safety not assess certain points for violations; prohibiting confiscation of certain devices and information; making certain exceptions; providing for codification; and providing an effective date.

Supp. 2024, Section 102.1), which relates to permits for erection, alteration, or modification of certain structures; modifying list requiring certain permit; detailing federal obstruction standards; requiring certain airports be included in statewide airport system plan; modifying certain list of considerations; amending 3 O.S. 2021, Section 421, as last amended by Section 15, Chapter 135, O.S.L. 2024 (3 O.S. Supp. 2024, Section 421), which relates to Department of Aerospace and Aeronautics established as clearinghouse for unmanned aircraft systems; requiring implementation of certain strategy; authorizing certain actions; authorizing certain partnerships; and providing an effective date.

HB 2297 – By Hilbert and Hill of the House and Hall of the Senate.

An Act relating to driver licenses; amending 47 O.S. 2021, Section 6-102, as last amended by Section 36, Chapter 452, O.S.L. 2024 (47 O.S. Supp. 2024, Section 6-102), which relates to reciprocity agreements with foreign countries; requiring Service Oklahoma enter into certain agreement with Ireland; and providing an effective date.

HB 2392 – By Adams, Hill and Sneed of the House and Seifried of the Senate. An Act relating to marriage and families; amending 43 O.S. 2021, Section 112.5, as amended by Section 37, Chapter 59, O.S.L. 2024 (43 O.S. Supp. 2024, Section 112.5), which relates to custody or guardianship; providing for presumption that parent is unfit; and providing an effective date.
