HB 1598 – By George and Menz of the House and Weaver of the Senate. [license plates - Disabled Veterans License Plates - effective date]

HB 1728 – By Moore, Archer and Menz of the House and Murdock of the Senate. An Act relating to invasive Salt Cedars; creating the Salt Cedar Eradication Act; defining terms; creating certain program; directing the Oklahoma Conservation Commission to oversee and implement the program along with cooperation from certain state agencies; authorizing the Oklahoma Conservation Commission to utilize certain funds; stating purpose of program; listing certain duties; authorizing the promulgation of rules and procedures; requiring certain annual report; creating the Salt Cedar Eradication Revolving Fund; providing for content of fund; providing for deposits and expenditures; providing for codification; providing an effective date; and declaring an emergency.

HB 2087 – By Kane, Hill and Pittman of the House and Hall of the Senate.

An Act relating to revenue and taxation; amending 68 O.S. 2021, Section 2357.45, which relates to income tax credits for donations to certain research institutes; modifying credit limit for donations to certain institutes in certain tax years; modifying credit amounts; modifying definition; and providing an effective date.

HB 2731 – By Kendrix and CrosswhiteHader of the House and Bergstrom of the Senate.

An Act relating to the Administrative Procedures Act; amending 75 O.S. 2021, Section 308.3, as amended by Section 6, Chapter 38, O.S.L. 2023 (75 O.S. Supp. 2024, Section 308.3), which relates to joint resolutions of the Legislature; updating reference to rule submission date; and providing an effective date.
