Seventeenth Legislative Day, Monday, March 3, 2025

MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1066, 1201, 1365, 1571** and **2762**.

HB 1066 – By Manger of the House and Murdock of the Senate.

An Act relating to criminal procedure; amending 22 O.S. 2021, Section 517, which relates to the withdrawal of guilty pleas; allowing for the withdrawal of guilty pleas; establishing time limitation for filing applications; requiring inclusion of certain information in application; and providing an effective date.

HB 1201 – By Maynard, Lepak and Boles of the House and Bullard of the Senate.

[revenue and taxation – contributions - tax credit – claim - resource centers - procedure – information - Tax Commission – requirements – cap - codification - effective date]

HB 1365 – By Culver of the House and Alvord of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2021, Section 396.3, as last amended by Section 1, Chapter 54, O.S.L. 2023 (59 O.S. Supp. 2024, Section 396.3), which relates to funeral director and embalmer examinations; establishing the Oklahoma Funeral Directors and Embalmers Examinations; and providing an effective date.

HB 1571 – By Lawson, Munson, Townley and Hill of the House and Gollihare of the Senate.

An Act relating to Route 66; amending Section 1, Chapter 412, O.S.L. 2022 (69 O.S. Supp. 2024, Section 4040), which relates to the Oklahoma Route 66 Commission; removing expiration date of the Oklahoma Route 66 Commission; amending Section 2, Chapter 412, O.S.L. 2022 (69 O.S. Supp. 2024, Section 4041), which relates to the Oklahoma Route 66 Commission Revolving Fund; modifying conditions for budgeting and expenditures of funds; and providing an effective date.

HB 2762 – By Caldwell (Trey) of the House and Woods of the Senate.

An Act relating to international corporation agents; creating the International Corporation Agent Political Activity Oversight Act of 2025; defining terms; prohibiting certain acts under certain conditions; requiring filing to perform certain acts; requiring certain information be included in filing; providing exception; amending 18 O.S. 2021, Section 1142, which relates to Secretary of State filing and service fees; establishing filing fee and establishing amount; authorizing certain acts to facilitate implementation; providing for noncodification; providing for codification; and providing an effective date.
