**HB 1200** – By Maynard, Kendrix, Lepak, Burns, Hill, Fetgatter, Townley, Boles and Cantrell of the House and Rader of the Senate.

[ revenue and taxation - Oklahoma taxable income - adjusted gross income - apportionment factors - effective date ]

**HB 1369** – By Boles and Waldron of the House and Green of the Senate.

An Act relating to oil and gas; amending 52 O.S. 2021, Section 318.1, which relates to evidence of financial ability for drilling and operating wells; phasing out category A surety;

modifying surety amounts; providing for tiered surety amount based on number of operating wells; and providing an effective date.

HB 1370 – By Boles and Waldron of the House and Green of the Senate.
[ Corporation Commission Plugging Fund – sunset – excise tax on oil and gas – taxes – sales tax amount – Interstate Oil Compact Fund of Oklahoma – cap - effective date - emergency ]

**HB 1591** – By George, Turner and Cantrell of the House and Weaver of the Senate. [crimes and punishments - required service of prison sentence - list of offenses - effective date]

**HB 1592** – By George, Turner, Cantrell and Wolfley of the House and Weaver of the Senate.

An Act relating to larceny; providing elements of organized retail crime; providing penalties; amending 21 O.S. 2021, Section 425, which relates to patterns of criminal offenses; expanding scope of offense; amending 21 O.S. 2021, Section 792, which relates to robbery; deleting exception; amending 21 O.S. 2021, Section 1731, as amended by Section 1, Chapter 176, O.S.L. 2024 (21 O.S. Supp. 2024, Section 1731), which relates to larceny of merchandise; modifying period of aggregated offenses; amending Section 1, Chapter 333, O.S.L. 2023 (21 O.S. Supp. 2024, Section 2200), which relates to the Oklahoma Organized Retail Crime Task Force; recreating Task Force; providing for the continuation of appointment selections; authorizing the Office of the Attorney General to staff the task force and employ task force officers; stating duties of officers; providing for codification; and providing an effective date.

**HB 1593** – By George and Cantrell of the House and Weaver of the Senate.

An Act relating to criminal procedures; defining terms; providing guidelines when evaluating the credibility of peace officers; authorizing peace officers to dispute reports of misconduct; directing the Office of the Attorney General to refer petitions to an administrative law judge; directing administrative law judge to find in favor of the peace officer under certain circumstances; prohibiting reliance on allegations of misconduct upon certain finding by the administrative law judge; directing administrative law judges to provide findings of fact and conclusions of law to the court; allowing for the disclosure of credibility issues to the court; providing for codification; and providing an effective date.

# **HB 1678** – By Townley of the House and Burns of the Senate.

An Act relating to elections; amending 26 O.S. 2021, Section 8-105, which relates to tie votes; directing for a second election to be held in the case of tie votes; and providing an effective date.

# **HB 1995** – By Turner of the House and Hamilton of the Senate.

An Act relating to crimes and punishments; amending 21 O.S. 2021, Sections 1111, as last amended by Section 8, Chapter 452, O.S.L. 2024, and 1123, as last amended by Section 33, Chapter 59, O.S.L. 2024 (21 O.S. Supp. 2024, Sections 1111 and 1123), which relate to

definitions of sex crimes; designating school resource officers as employees of a school system; and declaring an emergency.

HB 2026 – By Archer, Menz, Hill and Staires of the House and Haste of the Senate. An Act relating to aeronautics technology; amending Sections 1, 2, and 3, Chapter 125, O.S.L. 2024 (3 O.S. Supp. 2024, Sections 501, 502, and 503), which relate to the Oklahoma Aircraft Engine Testing Development Grant Program; modifying short title; expanding purpose of certain grant program; modifying name of certain revolving fund; directing deposit of certain monies in certain revolving fund; updating statutory references; providing an effective date; and declaring an emergency.

# **HB 2037** – By Archer of the House and Frix of the Senate.

An Act relating to energy conservation; repealing 19 O.S. 2021, Sections 456, 457, and 458, which relate to energy conservation; repealing 70 O.S. 2021, Section 5-131.2, which relates to energy conservation; and providing an effective date.

**HB 2155** – By Dobrinski and Waldron of the House and Green of the Senate. [ Corporation Commission - Renewable Energy Facility Act – rules - facility operators - penalties - permit - filing fee - codification – emergency ]

# **HB 2257** – By Miller of the House and Stanley of the Senate.

An Act relating to higher education; amending Section 1, Chapter 24, O.S.L. 2022 (70 O.S. Supp. 2024, Section 3231), which relates to the Oklahoma National Guard Educational Assistance Act; including program fees; requiring joint approval of fees; authorizing cap; requiring certain specialty to retain eligibility; authorizing Military Department to promulgate regulations; requiring collaboration on rules; and providing an effective date.
