MESSAGES FROM THE GOVERNOR

Advising his veto May 14, 2025, of Enrolled **SB 208**.

Veto message reads as follows:

May 14, 2025

TO THE HONORABLE PRESIDENT PRO TEMPORE
AND MEMBERS OF THE OKLAHOMA SENATE
FIRST REGULAR SESSION OF THE
SIXTIETH OKLAHOMA LEGISLATURE

ENROLLED SENATE BILL NO. 208:

Pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution, I have vetoed Enrolled Senate Bill 208.

I refuse to sign legislation that creates more unnecessary licenses for Oklahomans. We haven't needed a hunting guide license for the entirety of our history, and I see no need to create one now. I remain committed to limited government that focuses on real problems—not creating new hurdles to operating a business or hunting in our state.

For these reasons, I have vetoed Enrolled Senate Bill 208.
