
Energy Education Workshops

- Teachers who attend a workshop receive: professional development hours, \$100 stipend, a curriculum guide aligned to Oklahoma Academic Standards, and a kit of materials valued at up to \$1,200
- In FY 2025, 925 teachers were trained and received \$465,630.11 worth of kit materials for their classrooms
- 19,000+ teachers trained to date

Field Trips

- Teachers that complete the curriculum with their class are eligible for a FREE field trip to one of our partner museums
- 20,000+ students attended a field trip in FY

Scholarship Opportunities

Petroleum Scholars

- Available to students studying Energy Management, Geosciences, Petroleum Engineering, or GeoEnergy Engineering at the University of Oklahoma, Oklahoma State University, or the University of Tulsa
- Up to \$500,000 per year in scholarships to petroleum-related degree majors
- Over \$6M awarded to 1,242 students

- After completing a one-year term, OERB Student Board of Directors members will receive a \$2,000 scholarship to the university or trade school of their choice.

Our Restoration Work

Restoration

- Per statute, 50% of the annual budget must be spent cleaning up orphaned or abandoned well sites.
- Oklahoma is the only state in the nation with a Voluntary Restoration program.
- Not responsible for plugging. The OERB cleans up the surface damage only.
- Sites are recommended by the Oklahoma Corporation Commission (OCC) except in Osage County.
- The majority of sites cleaned up occurred in the 1910s 1960s.





Remaining Restoration Sites

- Through 2008, roughly 12,000 sites had been assessed and 9,000 sites had been restored since 1993. A study commissioned by the OERB in 2008 estimated that 35,000-51,000 sites remained requiring further assessment and or restoration.
- In 2008, the OCC estimated that approximately 75,000 sites remained to be restored in the state, excluding any sites located in Osage County.
- As of the end of November 2024, per OERB statistics:
 - -13,027 Projects (26,508+ Sites) have been referred
 - 9,067 Projects (21,145 Sites) have been Completed
- It is currently estimated that there are between <u>70,000 and 99,500</u> remaining oil and gas related sites in the State of Oklahoma (including Osage County) that will require some form of restoration.


Funding

- The OERB is funded by a voluntary assessment of one-tenth of one percent of the gross revenues received for oil, natural gas, casinghead gas, or condensate produced from each well in Oklahoma except for production exempt from the gross production tax.
- The Oklahoma Tax Commission collects the assessment along with the gross production tax and transfers those collections into a dedicated Revolving Fund.
- Historically, 90-95% of all contributions remain in the fund, making ours one of the most strongly supported checkoff programs in the country.

Budget

 By statute, at least 50 percent of funding (after refunds and administrative costs) must be allocated to environmental restoration.

• The OERB operates like a streamlined business, keeping administrative costs below 10%.



Refunds

- The Oklahoma Tax Commission collects the assessment along with the gross production tax (GPT) and transfers those collections into a dedicated Revolving Fund. SOER has a separate Revolving Fund dedicated to producer education.
- The first purchaser pays the OERB/SOER assessments based on the Gross oil/natural gas production purchased.
- Any person or entity (producer or royalty owner) that does not wish to participate can apply for a refund each year for the NET production owned by that person or entity.
- The refund period is January 1 March 31 for the prior year's contribution.
