Yes, the work can be heavy at times; but it is worth it.





- 12,000 Personal Safety Plans distributed to individuals and families
- 300+ firearms community members trained in QPR suicide prevention



Reasons for Voluntary Off-site Firearms Storage Include...

- Life Transitions travel, military deployment, home sale, college dorm living, estate administration
- Health & Recovery medical treatment, mental health care, medication changes
- Family Safety divorce, foster children, relatives with dementia, prohibited person, event hosting
- Housing Instability homelessness, domestic violence shelter, temporary housing

Note: The gun owner may not be in crisis! Voluntary off-site storage is often an act of responsibility to protect others in the household from unauthorized access.



Observations From the Field: Hesitations and Barriers to Off-site Firearms Storage

- Restrictions on Private Transfers prohibit temporary storage with trusted friends or family.
- Assault Weapon and Magazine Bans complicate lawful storage of firearms and accessories.
- **Privately Manufactured Firearms Requirements** serialization requirements complicate storage and return.
- Mandatory Waiting Periods delay retrieval and discourage participation.
- **Federal Age Restriction Gap** prevents lawful return of firearms to owners ages 18–20.
- Lack of Liability Protections exposes FFLs to civil suits even when acting in good faith.
- "Nuisance" Designations of FFLs increase liability exposure and deter storage partnerships.
- **NFA Regulatory Burdens** suppressors and other items require costly, reapplication process
- Background Check Errors clerical mistakes at pickup can trigger unnecessary investigations.
- Privacy and Stigma gun owners fear being presumed "in crisis" for seeking storage.
- Mandate Concerns worry that voluntary options could evolve into compulsory requirements.
- Stigmatizing Language terms like "gun violence" alienate lawful gun owners and reduce trust.
- ERPO/Red Flag Laws create fear that seeking help could lead to loss of firearms and rights.



Building on Oklahoma's Legacy of Liberty: Strengthening Voluntary Storage Solutions



- Provide Liability Protections shield FFLs offering storage in good faith from civil suits.
- Clarify Age Gap authorize return of lawfully stored firearms to owners ages 18–20.
- **Comprehensive Storage Protection** ensure all firearms, ammunition, and accessories may be stored and returned without restriction or forced serialization.
- Affirm Voluntariness codify that storage programs remain strictly voluntary and cannot become compulsory.
- **Safeguard Privacy** prohibit use of customer information for registries, databases, or research.
- **Protect FFL Standing** prohibit "nuisance" or zoning classifications that increase liability for licensed dealers.
- Streamline NICS Corrections establish quick remedies for background check errors that block lawful retrieval.
- Adopt Respectful Messaging avoid broad, stigmatizing terms such as "gun violence" in legislation or outreach; use precise language (e.g., suicide by firearm) to maintain trust with lawful gun owners.



Additional Ways Oklahoma Can Help Promote Voluntary Firearms Storage:

- Recognize Voluntary Storage in Policy integrate voluntary storage into state safety and suicide prevention frameworks as a rights-respecting option.
- **Expand Awareness Channels** partner on statewide campaigns to educate the public and professional communities about voluntary storage.
- Collaborate with Local Stakeholders engage law enforcement, hunter safety instructors, medical and mental health providers, veterans' groups, colleges, and community services.
- **Encourage Community Outreach** support workshops, resource fairs, and veteran-focused initiatives through partner FFLs.
- Strengthen Referral Pathways equip leaders with clear guidance to connect individuals to voluntary storage without stigma.
