The Alcoholic Beverage Laws Enforcement Commission consist of seven members appointed by the Governor with the advice and consent of the State Senate. Five of the members represent the lay citizens at-large; the remaining two are required to poses experience in law enforcement. Members are appointed for terms of five years. The state constitution directs that no more than four of the Commission members shall be from the same political party and no more than two of the members shall be from the same federal congressional district. In addition, the constitution prohibits any Commission member from holding an alcohol license.
