

# Senate Journal

## First Regular Session of the Forty-ninth Legislature of the State of Oklahoma

Sixth Legislative Day, Monday, February 10, 2003

The Senate was called to order by Senator Rozell.

### UNANIMOUS CONSENT REQUEST DIRECT TO CALENDAR

Senator Leftwich asked unanimous consent to suspend Rule 5-4 and refer **SR 1** direct to the Calendar for consideration, which was the order.

**GENERAL ORDER**

**SR 1** by Leftwich and Shurden was called up for consideration.

All other members of the Senate asked to coauthor **SR 1**, which was the order.

**SR 1** was adopted upon motion of Senator Leftwich and referred for enrollment.

**SENATE RULE SUSPENDED**

Senator Wilkerson move to suspend Senate Rule 5-7(B) as it pertains to **SB 8**, which motion was declared adopted.

**GENERAL ORDER**

**SB 8** by Wilkerson of the Senate and Roberts of the House was called up for consideration.

Senator Wilkerson moved to amend **SB 8**, by striking the title, the enacting clause and the entire body of the bill and substituting the floor substitute, which amendment was declared adopted. (Copies were provided for all Senators.)

Senator Wilkerson moved that **SB 8** be advanced, which motion was declared adopted.
