An Act relating to schools; amending 70 O.S. 2001, Section 1-111, as amended by Section 1, Chapter 453, O.S.L. 2002 (70 O.S. Supp. 2002, Section 1-111), which relates to school enrollment; adding certain criteria for Internet-based courses; requiring board of education approval for enrollment in Internet-based course; providing an effective date; and declaring an emergency.

(drug offenses – amending 22 O.S, Section 471.4 – drug court investigation – amending 63 O.S., Section 2-307 – records of registrants – amending 21 O.S., Section 832 – poison or drugs – effective date)

(public health and safety – amending 63 O.S., Section 3101.4- Rights of the Terminally III or Persistently Unconscious – effective date)
