**Nineteenth Legislative Day, Wednesday, March 3, 2004**

“pursuant to the following schedule: A taxpayer relocating outside the state less than seven (7) years after receiving any incentive payment shall be required to repay one hundred percent (100%) of the amount initially received; a taxpayer relocating outside the state more than seven (7) years but less than nine (9) years after receiving any incentive payment shall be required to repay eighty percent (80%) of the amount initially received; a taxpayer relocating outside the state more than nine (9) years but less than ten (10) years after receiving any incentive payment shall be required to repay sixty percent (60%) of the amount initially received; a taxpayer relocating more than ten (10) years after receiving any incentive payment shall be relieved of any obligation to repay the state for any incentive payment received. If a taxpayer ceases to exist and the taxpayer’s assets are transferred to a successor entity for less than fair market value consideration, the successor entity shall be subject to repayment as required by this section”; and Page 2, Line 5 ½ by inserting a new Section 2 to read as follows:

“SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 206.3 of Title 68, unless there is created a duplication in numbering, reads as follows:

Political subdivisions of this state, including but not limited to counties, cities and towns, offering incentives to taxpayers in conjunction with any state incentives listed in Section 206.2 of to amendments relocates outside of the political subdivision which provided incentives. Said repayment shall be pursuant to a contract executed between the taxpayer and the political subdivision or agent of the political subdivision authorized to develop and execute incentive packages for job creation.”; and by renumbering subsequent section, which amendment was declared adopted.
