## Second Regular Session of the Forty-ninth Legislature of the State of Oklahoma

**Forty-third Legislative Day, Wednesday, April 14, 2004**

Senator Corn moved to amend the Williamson amendment on **HB 2661**, Page 106, Line 8 ½, by inserting a new Section 71 to read as follows:

“SECTION 71. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 999 of Title 36, unless there is created a duplication in numbering, reads as follows:

A. For any coverage for medical malpractice insurance, property insurance and casualty insurance excluding, accident and health insurance, workers' compensation insurance and employer liability insurance, issued or renewed on or after July 1, 2005, every insurer shall reduce its charges by at least ten percent (10%) less than the charges for the same coverage that were in effect on January 1, 2003. For any such coverage issued or renewed on or after July 1, 2006, every insurer shall reduce its charges by at least an

additional ten percent (10%). For any such coverage issued or renewed on or after July 1, 2007, every insurer shall reduce its charges by at least an additional five percent (5%).

B. Rates and premiums reduced pursuant to subsection A of this section may be increased only to the extent that the State Board for Property and Casualty Rates finds, after an open hearing at which a record is made, that an insurer is unable to earn a fair rate of return.

C. Insurance rates for medical malpractice insurance shall be approved by the State Board for Property and Casualty Rates prior to being implemented.

D. Any separate affiliate of an insurer is subject to the provisions of this section.

E. The State Board for Property and Casualty Rates shall produce an annual independent report by December 1, 2005, and each year thereafter for the Governor, the Speaker of the House of Representatives and the President Pro Tempore of the Senate regarding the cost savings to insurers for bodily injury claims and lawsuits as a result of this act. Information in the report shall include but not be limited to the number of claims and lawsuits filed, amount of awards and settlements and the impact on premium costs for property insurance, including but not limited to homeowners' insurance, and casualty insurance, including but not limited to vehicle and medical malpractice insurance, but excluding accident and health insurance, workers' compensation insurance and employer liability insurance.

F. The Board shall be authorized to employ actuaries, statisticians, accountants, auditors, attorneys, or any other technicians as the Board deems necessary to make the independent report.

G. The cost of the report shall be borne by the Department of Insurance.

H. All expenses incurred for the report shall be verified by affidavit and a copy shall be filed and kept in the office of the Insurance Commissioner.

I. All insurers providing property insurance, including but not limited to homeowners' insurance, and casualty insurance, including but not limited to vehicle and medical malpractice insurance, but excluding accident and health insurance, workers' compensation and employer liability insurance, shall provide information on an annual basis to the Department as required by the Board.

J. All insurers required to provide information pursuant to subsection I of this section shall verify by affidavit that the information is complete and accurate and a copy of the affidavit shall be kept in the office of the Insurance Commissioner.

K. The Insurance Commissioner shall promulgate any rules necessary to implement the provisions of this section.", and by renumbering subsequent sections, which amendment was declared adopted upon roll call as follows:
