## First Regular Session of the Fiftieth Legislature of the State of Oklahoma

Forty-second Legislative Day, Tuesday, April 19, 2005

Enrolled Senate Bill No. 260

This is to advise you that on this date, pursuant to the authority vested in me by Section 11 of Article VI of the Oklahoma Constitution to approve or object to legislation presented to me, I have VETOED Senate Bill 260. This bill gives sole jurisdiction to the Department of Labor over investigations, inquiries into accidents and incidents relating to amusement ride safety. While this idea has merit and the Department of Labor should have “concurrent” jurisdiction along with other appropriate law enforcement agencies, this legislation, as drafted, is inflexible, and totally usurps the jurisdiction of all other appropriate law enforcement agencies.
