Fifth Legislative Day, Monday, February 13, 2006**

### GENERAL ORDER

**SB 1020** by Easley et al of the Senate and Rousselot of the House was called up for consideration.

Senators Gumm, Lawler, Justice, Riley, Ford, Wilcoxson, Barrington, Anderson, Coates, Laughlin, Branan, Reynolds, Johnson (M), Myers, Jolley, Corn, Brogdon, Leftwich, Eason McIntyre, Crutchfield, Garrison, Adelson, Shurden, Harrison and Wyrick asked to coauthor **SB 1020**, which was the order.

Senator Easley moved to amend **SB 1020**, by striking the title, the enacting clause and the entire body of the bill and substituting the floor substitute, which amendment was declared adopted. (Copies were provided for all Senators.)

Senator Easley moved to amend the floor substitute to **SB 1020**, Page 2, Lines 4 and 5, by deleting all language and inserting in lieu thereof the following language “the period from one hour before the scheduled commencement of funeral services until one hour after the actual completion of the funeral services.”, which amendment was declared adopted.

Senator Easley moved to amend the floor substitute to **SB 1020**, Page 1, by restoring the title, which amendment was declared adopted.

Senator Easley moved that **SB 1020** be advanced, which motion was declared adopted.

### THIRD READING

**SB 1020** was read for the third time at length.
