Second Regular Session of the Fiftieth Legislature of the State of Oklahoma

Twelfth Legislative Day, Monday, February 27, 2006

An Act relating to public health and safety; amending Section 12, Chapter 200, O.S.L. 2005, Section 13, Chapter 200, O.S.L. 2005 and Section 14, Chapter 200, O.S.L. 2005 (63 O.S. Supp. 2005, Sections 1-740.2, 1-740.3 and 1-740.4), which relate to abortion performed upon unemancipated minors; requiring written informed consent of parent; modifying delivery requirements; modifying exceptions; requiring certain entity to adopt consent form; requiring retention of consent form for certain time period; expanding scope of judicial bypass of notice requirement and appeals procedure; updating statutory

reference; modifying scope of criminal penalty and civil remedies; and declaring an emergency.

An Act relating to public health and safety; enacting the Unborn Child Pain Awareness/Prevention Act; defining terms; making certain unborn child pain information available to pregnant females; requiring certain certification by the female; requiring the State Board of Medical Licensure and Supervision to make available certain information; providing for Internet web site; providing for certain reporting forms; specifying content and purpose of forms; providing penalties; setting privacy requirements for certain court proceedings; providing for severability; providing for codification; and declaring an emergency.

An Act relating to the Oklahoma Public Employees Retirement System; providing for election by certain participating employers of the Oklahoma Public Employees Retirement System to cease participation; providing for irrevocable and binding nature of election; prescribing procedures related to election; providing for effect of election upon employer and employee contributions; requiring payment of actuarial cost by withdrawing municipality or rural water district; providing for codification; providing an effective date; and declaring an emergency.

An Act relating to public health and safety; amending 63 O.S. 2001, Section 1-738, which relates to abortion; creating the Statistical Reporting of Abortion Act of Oklahoma; providing short title; providing definitions; providing for the State Department of Health to prepare reporting forms; providing for the Board to distribute reporting forms; providing content of reporting forms; providing for the Board to prepare and distribute an induced abortion complications report; providing the time in which reports are due; providing content complications reporting form; requiring public reports containing certain information; providing time in which certain reports must be filed; providing for enforcement of reporting requirements; providing for penalties; providing for confidentiality; providing for severability; providing for codification; and providing an effective date.

HB 2880 – By Young and Nance of the House and Leftwich of the Senate.

An Act relating to statutes and reports; amending Section 3, Chapter 495, O.S.L. 2002, as last amended by Section 1, Chapter 55, O.S.L. 2005 (75 O.S. Supp. 2005, Section 503), which relates to the Small Business Regulatory Review Committee; modifying term of

office for certain appointees; providing for appointments to fill vacancies; and providing an effective date.

HB 3016 – By Armes, Jackson, Braddock, Duncan and McMullen of the House and Capps of the Senate.

An Act relating to game and fish; amending 29 O.S. 2001, Sections 5-202 and 6-304, which relate to permission to hunt or fish upon the land of another; creating presumption that consent to hunt or fish is valid for specific period of time; updating statutory language; and providing an effective date.
