Senator Williamson moved to amend **SB 1993**, Page 3, Line 10, by inserting after the word "title" and before the period the language "and Section 2 of this act."; Page 3, Line 11, by inserting after the letter "D." and before the word "A", the number and period "1."; Page 3, Line 15, by inserting before the word "Beginning", the number and period "2."; Page 3, Line 16, by deleting the word "not"; Page 3, Line 18, by deleting after the word "parent(s)" and before the word "Seventy", the word "exceeds" and inserting the language "is more than Fifty Thousand Dollars (\$50,000.00) but less than or equal to"; Page 3, Line 19, by inserting after the word "year" and before the period the language "and such students shall be eligible for an award as provided for in Section 2 of this act in lieu of an award as provided for in Section 2604 of this title"; Page 3, Line 19, by inserting after the period and before the word "The", the number and period "3."; and Page 5, Line 13 1/2, by inserting a new SECTION 2 to read as follows:

"SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 2606 of Title 70, unless there is created a duplication in numbering, reads as follows:

A. The Oklahoma State Regents for Higher Education shall award payments as provided in this section to eligible participants in the Oklahoma Higher Learning Access Program who:

1. Qualify pursuant to paragraph 2 of subsection D of Section 2605 of Title 70 of the Oklahoma Statutes;

2. Complete the requirements for a baccalaureate degree; and

3. Are subsequently employed by an employer located in this state for a minimum of one (1) year.

B. Total amounts awarded shall be equivalent to awards provided in Section 2604 of Title 70 of the Oklahoma Statutes. An amount equivalent to twenty percent (20%) of the total award shall be paid to an eligible participant at the completion of each year of employment in this state for a maximum of five (5) years. In the event a participant has outstanding student loans, award payments shall be applied to the balance of the student loans first. Any amount not necessary to repay the balance of the student loans shall be paid directly to the participant.

C. If insufficient funds are available for awards to eligible participants as provided for in this section, the Chancellor of Higher Education may make reductions in the payments made to eligible participants.”, by renumbering subsequent sections, and by amending the title to conform.

No institution of higher education within The Oklahoma State System of Higher Education shall give preferential treatment to students based upon their housing decision.”, and by amending the title to conform.
