SJR 38 – By Corn of the Senate and Smithson of the House

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to Section 4 of Article III of the Oklahoma Constitution; requiring all statewide voting systems be paper-based; providing ballot title; and directing filing.

BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 50TH OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the following proposed amendment to Section 4 of Article III of the Constitution of the State of Oklahoma to read as follows:

Section 4. The Legislature shall prescribe the time and manner of holding and conducting all elections, and enact such laws as may be necessary to detect and punish fraud in such elections. All voting systems in this state shall be paper-based unless otherwise as prescribed by federal law. The Legislature may provide by law for the registration of electors throughout the state and, when it is so provided, no person shall vote at any election unless he the person shall have registered according to law.

SECTION 2. The Ballot Title for the proposed Constitutional amendment as set forth in SECTION 1 of this resolution shall be in the following form:
