HB 1517 – By Liebmann of the House and Corn of the Senate.

An Act relating to roads, bridges and ferries; repealing 69 O.S. 2001, Section 504, which relates to maintenance of streets, roads and state-owned parking lots on Capitol grounds; providing an effective date; and declaring an emergency.

HB 2145 – By Ellis, Nance, Liotta, Dorman, Lamons and Morgan (Fred) of the House and Shurden of the Senate.

An Act relating to crimes and punishments; amending 21 O.S. 2001, Section 13.1, as amended by Section 7, Chapter 22, O.S.L. 2002 (21 O.S. Supp. 2005, Section 13.1), which relates to mandatory minimum percentage of sentence to be served for certain offenses; adding certain offense to mandatory minimum percentage requirement; providing an exception; and providing an effective date.

violations of the act; providing damages; authorizing courts to increase damages in certain circumstances; allowing recovery of certain fees and costs; making unlawful acts under act violations of the Oklahoma Consumer Protection Act; exempting certain actions by telecommunications providers or Internet service providers from the act; providing for codification; and providing an effective date.
