Senator Laughlin raised a point of order that the Fisher substitute motion was not signed when Senator Laughlin filed his substitute motion and that Senator Laughlin's substitute motion to accept the **HA's** on **SB 2022** and advance the bill to final passage was in order.

The Chair ruled that the Fisher substitute motion was signed and in order. The Chair further ruled that the Laughlin substitute motion was out of order because it had the same intent as the original motion to adopt the **HA's**.

Senator Laughlin challenged the ruling of the Chair that pursuant to Senate Rule 13-7, there shall only be one substitute motion for a motion of equal priority.

Senator Fisher debated that pursuant to Senate Rule 12-8, that Laughlin substitute motion was not in order.

The Chair stated again his ruling that the Laughlin motion to accept the **HA's** and advance the bill had the same impact and effect as the original motion and was not eligible to be a substitute motion.
