Forty-fifth Legislative Day, Tuesday, April 22, 2008

“SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1E of Title 82, unless there is created a duplication in numbering, reads as follows:

Should a final judgment of a court of competent jurisdiction mandate that this state or any political subdivision thereof sell, export or transfer water under its control and jurisdiction, such conveyance shall not be done without compensation to the state or any such subdivision. Compensation means the value of the water taken, and in addition, any injury caused by the taking of the water.”, and by renumbering subsequent sections and amending the title to conform, which amendment was declared adopted.

Senator Schulz moved that **HB 3135** be advanced, which motion was declared adopted.
