Fifty-second Legislative Day, Monday, May 5, 2008

*Lieutenant Governor Askins asked to be shown not voting on **SB 1987** for reason of personal interest, as provided in Article V, Section 24, Oklahoma Constitution.

The motion to adopt the **HAs** to **SB 1987** failed of adoption.

Senator Brogdon moved to reconsider the vote whereby the adoption of the **HAs** failed.

Senator Gumm raised a point of order, that according to Senate Rule 13-22E, to reconsider an action other than a Third or Fourth reading, a Senator must have voted in the majority, and that the vote to adopt the **HAs** on **SB 1987**, did not have a majority since it was a tie.

The Chair ruled the Gumm point of order well taken.
