First Regular Session of the Fifty-second Legislature of the State of Oklahoma Forty-eighth Legislative Day, Thursday, April 23, 2009

“Contracts entered into pursuant to this act shall not be subject to the Oklahoma Central Purchasing Act, and the request for proposal process shall be subject to the discretion of the agency head or his or her designee.”, which amendment was declared adopted.
