MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HB 2750** and **HCR 1044** .

HB 2750 – By Denney, McDaniel (Jeannie), Sullivan, Coody, Nelson, Dorman and Kern of the House and Justice of the Senate.

An Act relating to schools; directing the State Board of Education to incorporate April 19, 1995, bombing information into the Oklahoma history social studies core curriculum; stating importance of studying the bombing and its aftermath; authorizing the State Department of Education to make certain program materials and resources available to schools; directing the State Textbook Committee to incorporate certain criteria in the evaluation of certain textbooks; providing for codification; providing an effective date; and declaring an emergency.

HCR 1044 – By Bengé and DeWitt of the House and Coffee and Myers of the Senate. A Concurrent Resolution designating February 9, 2010, “Water Appreciation Day” at the State Capitol; encouraging recognition of the value and significance of water resources; and directing distribution.
