An Act relating to motor vehicles; amending 47 O.S. 2001, Section 11-309, as last amended by Section 1, Chapter 125, O.S.L. 2009 and Section 3, Chapter 108, O.S.L. 2003 (47 O.S. Supp. 2009, Sections 11-309 and 11-901b), which relate to rules of the road; modifying requirements for driving vehicles on certain roadways; modifying circumstances for which a citation may be issued; providing statutory reference for penalty provision; and providing an effective date.

HB 2540 – By Cooksey and Sullivan of the House and Jolley of the Senate.

An Act relating to sex offenders; amending Section 1, Chapter 223, O.S.L. 2003, as last amended by Section 2, Chapter 347, O.S.L. 2008 (57 O.S. Supp. 2009, Section 590), which relates to the Sex Offenders Registration Act; modifying scope of certain criminal act; and providing an effective date.

HB 2551 – By Roan and Cox of the House and Paddock of the Senate.

An Act relating to public health and safety; amending Section 1, Chapter 43, O.S.L. 2008, Section 2, Chapter 43, O.S.L. 2008 and Section 3, Chapter 43, O.S.L. 2008 (63 O.S. Supp. 2009, Sections 1-2505.1, 1-2505.2 and 1-2505.3), which relate to death benefits for emergency medical technicians; providing death benefit for registered emergency medical responders; modifying revolving fund name; modifying fee amount for certain license application or renewal; amending 68 O.S. 2001, Section 2358, as last amended by Section 1, Chapter 436, O.S.L. 2009 (68 O.S. Supp. 2009, Section 2358), which relates to computations of adjusted gross income and taxable income; providing income tax exemption for death benefit amount for registered emergency medical responders; providing effective dates; and declaring an emergency.

Supp. 2009, Section 178.6), which relates to public trusts; modifying provisions related to financing of housing; authorizing refinancing; deleting certain restriction related to exempt property; and providing an effective date.

HB 2623 – By Ownbey and Liebmann of the House and Bingman of the Senate.

An Act relating to state government; amending 74 O.S. 2001, Section 840-5.5, as last amended by Section 1, Chapter 300, O.S.L. 2008 (74 O.S. Supp. 2009, Section 840-5.5), which relates to unclassified service positions; adding unclassified positions to the Oklahoma State Bureau of Investigation; and providing an effective date.

HB 2678 – By Faught of the House and Jolley of the Senate.

An Act relating to professions and occupations; amending 59 O.S. 2001, Section 3006, as amended by Section 9, Chapter 261, O.S.L. 2009 (59 O.S. Supp. 2009, Section 3006), which relates to the Orthotics and Prosthetics Practice Act; modifying licensing procedures; and providing an effective date.

HB 2748 – By Denney and Pittman of the House and Halligan of the Senate.

An Act relating to crimes and punishments; amending 21 O.S. 2001, Section 1247, as last amended by Section 1, Chapter 70, O.S.L. 2007 (21 O.S. Supp. 2009, Section 1247), which relates to smoking in public areas and indoor workplaces; designating education facilities as nonsmoking as provided for in the Smoking in Public Places and Indoor Workplaces Act; authorizing institutions within The Oklahoma State System of Higher Education to be designated as tobacco free; providing for adoption of a policy by the institution; and providing an effective date.

HB 2906 – By Morgan, Pittman, Luttrell, Roan and Hoskin of the House and Eason McIntyre of the Senate.

An Act relating to mental health; amending 43A O.S. 2001, Section 10-104, as last amended by Section 3, Chapter 68, O.S.L. 2007 (43A O.S. Supp. 2009, Section 10-104), which relates to report required for vulnerable adult suffering abuse; adding municipal employees to entities required to make report; creating the Vulnerable Adult Intervention Team Pilot Program; providing for purpose; establishing the interdisciplinary team; providing for appointments; providing for duties; requiring certain report; providing for codification; and declaring an emergency.

"B. If the State Board of Equalization determines that a revenue failure has occurred with respect to the General Revenue Fund of the State Treasury for a fiscal year, the

salaries of the officers specified in subsection A of this section shall be reduced for the remainder of the fiscal year in a percentage amount commensurate with the percentage of the projected revenue failure.”, which amendment was declared adopted.
